During the meeting following points were discussed/ reviewed:

- 1. The board reviewed the results of Bcom (Hons) declared during the year which was above 80 % and found them satisfactory and discussion was also done on the corrective measures to be taken to improve the result.
- 2. The Board went through the changes/recommendations/moderation made by the faculty members of Amity College of Commerce in the syllabus of B.com. (H) Program and approved the same. Changes were made in the syllabus of B.com. (H) Program in the following courses.
 - The syllabus of Indirect taxation has been changed 100% as the Goods and Service Tax Act has replaced all the previous Indirect Taxes which were earlier part of the old syllabus.
 - The syllabus of Business taxation has also been changed 80% as the new Goods and Service Tax Act has been introduced and has replaced all units relating to Sales Tax in the old syllabus. The unit relating to Custom Act remains same as before.
 - The course of Principles of Marketing has been shifted from B.com (Hons) II Sem to B.com (Hons) I sem in order to prepare the basic foundation of the students for the course "Advertising Management" which has been introduced in B.com (Hons) II sem and also E Commerce has been shifted from core course to concentration elective so that the relevance of ecommerce and the credit hours are not compromised.
