#### Q1. Where is Deakin University Located?

Deakin University is located in Melbourne Australia.

#### Q2. Tell me more about Deakin University?

Deakin University is an Australian public university with approximately 47,000 higher education students in 2014.

Established in 1974, the University was named after the leader of the Australian federation movement and the nation's second Prime Minister, Alfred Deakin.

It has campuses in Geelong, Warrnambool and Burwood, Melbourne in the state of Victoria.

The university receives more than A\$600 million in operating revenue annually, and controls more than A\$1.3 billion in assets. It received more than A\$35 million in research income in 2011 and had 1.493 research students in 2012.

In 2009, its academics authored 33 books, 233 refereed conference papers, and 705 refereed journal papers.

# Q3. Is Deakin University ranked amongst the Top in the world? What are the rankings?

The prestigious ranking agencies of the world have constantly ranked Deakin University amongst the top Universities of the world.

According to the Times Higher Education Ranking, Deakin University is ranked 301-350

According to the QS rankings, it is ranked t 380.





# Q4. How many years will I study at Deakin University? What is the Academic Model?

You have two options to choose from:

OPTION 1 - 2+1 Model – You will spend two years at Amity University followed by one year at Deakin University

OPTION 2 - 1 + 2 Model - You will spend one year at Amity University followed by two years at Deakin University.

#### Q5. Will I Get Post Study Working rights in Australia?

In option 1 there will be no post study working rights until you stay on for a Master's Degree in Australia.

In Option 2 you will be eligible for post study working rights.
