# **Practice of Online Teaching in Teacher Education**

#### **Abstract**

Due to the situation of this deadly pandemic 'Covid 19', the educational processes have shifted to online mode in the whole world. At this juncture, on one hand, the teachers were forced to imbibe the advanced technological skills and on the other hand to find more efffective and suitable online teaching learning process. As a result, all the teachers are experimenting with different and advanced innovative methods, techniques and resources. It is true that it is found happening in the teacher education field too. In India, there were a systematic monitoring and transaction of teacher education curriculum at both undergraduate and post graduate level with the guidance of National Council for Teacher Education (NCTE). Universities and higher educational institutes were maintaining the rules and regulations of NCTE. In this particular pandemic situation, this study aims to focus on how the prospective teachers are experiencing the online learning and what are their suggestions to improve the teaching transactions through online mode. This study was conducted among the prospective teachers those currently pursuing their post graduation in Education, under Kannur University, Kerala, India. 13 participants were involved in this discussion along with the teacher educator who is also the author of this current study. This study is an attempt to bring out the current scenario of the process of Online teaching learning, particularly in the field of Teacher education. The study also gives an idea on practical way of conducting online classes and developing the necessary skills among the future teachers.

### Introduction

Teacher Education in India has a wide scope and tremendous effect on preparing the prospective teachers for its future citizens. National Council for Teacher Education (NCTE) is the nodal governmental agency to monitor the teacher education programmes in India. As per the regulations of the NCTE, many Universities and Higher Educational Institutions are offering various specialized teacher education programmes in India. As per the NCTE regulations of 2014, the undergraduate and post graduate teacher preparation programmes have been discussing various issues and subject papers and giving sufficient practical experience for the prospective teachers. Strict monitoring was also been undergoing from the governmental agencies to evaluate the institute wise and individual wise evaluation process.

### Need and significance of the study

### Methodology

The present study was conducted in the School of Pedagogical Sciences, Under Kannur University, Kerala, India. Data was collected from 13 prospective teachers of third semester of the two years Master of Education Programme, enrolled in 2020. Data was collected through both the quantitative and qualitative mode in the form of conducting group discussion, collecting individual feedback administered in person and collected through online google forms. Various questions asked for getting the reflections as part of the purpose of this paper are as follows:

- What kind of teaching strategies will be applicable in online mode?
- Are your teachers giving follow up activities during regular teaching and online teaching? How?
- What are the resources the teachers are providing to you during online classes?
- What are your suggestions to improve the online teaching in teacher education field?
- Which transactional method is appropriate for you during online teaching?
- Which are the reference sources you are utilizing during online classes?
- Give your views and concerns on online teaching in teacher education
- As a teacher how will you engage your students through online teaching?
- What are the Roles and Responsibilities of Online Instructors?
- According to your view, what are Competencies required for Online Instructors?
- How can we encourage teachers and learners participation through online platforms?

As the students were well qualified and well experienced, they are given their sincere reflections regarding the scope of online teaching in the teacher

education field. Certain demographic details were also collected for the triangulation of the present study.
