## **Dissertation Guidelines**

- A. Dissertation to be hard bound.
- B. Two copies to be submitted to the Institute.
- C. Dissertation to be submitted should consist the following:
  - i) Cover page as per Annexure-I. (Ink Blue Base/Printing in Silver Color)
  - ii) Title page as per Annexure-II
  - iii) Declaration by the student about the originality of work as per Annexure-III
  - iv) Certificate by the Supervisor as per Annexure-IV
  - v) Acknowledgement
  - vi) Table of contents
  - vii) Table of cases with pagination
  - viii) List of abbreviations
  - ix) List of tables/figures
  - x) Chapters
  - xi) Bibliography
- D. Plagiarism check is essential with reference to (Promotion and Academic Integrity & prevention of Plagiarism in Higher Educational Institutions) Regulation 2018. The Plagiarism check certificate shall be issued by the Dissertation Committee. Maximum permitted limit for similarity index is 20%.
- E. The Dissertation shall consist of 100-120 pages divided into minimum of 5 (Five) chapters inclusive of Introduction and Conclusion. The chapters must be at least 15 pages barring the last chapter. Chapter 1 Introduction shall consist of following sub-heads and in same order:
  - i) Introductory paragraph.
  - ii) Statement of Problem
  - iii) Objectives of Research
  - iv) Hypothesis/Hypotheses

### F. Periodic mandatory meeting

- i. There shall be a periodic mandatory meeting of the students with their supervisors at a gap of 15 days. The student is required to sign the Dissertation progress tracker. The progress tracker shall be a part of documents to be kept before the Evaluation Board, Dissertation.
- ii. The submission of the work shall be on periodic basis and shall be duly documented.
- iii. The students shall submit the preliminary draft of the Dissertation in soft copy to their respective supervisors for the plagiarism test to be conducted.
- iv. The final draft shall be submitted in hard copy in the last working day of April.

# **Formatting Rules**

- i. Each chapter should have a title, which should be in the center and placed two inches from the top, in uppercase.
- ii. All pages must be numbered, with the preliminary pages marked in roman numbers, and the main chapters, annexures and references/bibliography in Indo-numeric style, beginning from page number 1. All numbers should be placed in the bottom, center of the page.
- iii. Margin of the left should be 1.5 inches, with top, bottom and right hand margin at 1 inch.
- iv. Font size:
  - Level One Heading Times New Roman, font size 14, Numbered, Centered & Bold
  - Level Two Heading Times New Roman & font size 12, Left aligned & bold.
  - Level Three Heading Times New Roman & font size 12, left aligned & Italicized
  - Font size to be used for the text shall be Times New Roman 12 with the line spacing of 1.5.
  - Font size for footnote shall be Times New Roman 10.

#### C. Mode of Citation of Case Law

- (i) Where the case title is written in the body of the text, only the name of the case shall be in the text e.g. *Kesavananda Bharathi* v. *State of Kerala* and the citation is written in the footnote as AIR 1973 SC 1461.
- (ii) If the name and citation are to be written in the footnote itself: *Kesavananda Bharati* v. *State of Kerala*, AIR 1973 SC 1461.
- (iii) If parties to a case are numerous, e.g. *State of Punjab* v. *Union of India and others*; this case is to be cited as: *State of Punjab* v. *Union of India* (1977) 3 SCC 592.
