STUDENTS ADMITTED THROUGH SPOT COUNSELLING

The students who have taken admission through Spot Counselling in Amity Law School, Delhi are hereby informed that they should report at Amity Law School, F1-Block, 1st Floor, Amity University Campus, Sector-125, Noida to complete the further formalities of admission till 31st July 2015 by 2:00 pm.

In addition to the fee of Rs. 60,000/- already paid to the IP University, <u>the students</u> are required to pay an additional amount of Rs. 11,200/- (Rupees Eleven thousand and Two Hundred only).

<u>IMPORTANT NOTE</u>: The fee shown as above is a provisional amount, based on the decision for Academic Session 2011-12. The fee structure for session 2012-13, 2013-14 is under revision by State Fee Regulatory Committee. <u>In case there is any revision of fee by the State Fee Committee for the Academic session 2014-15, then the candidates will have to pay the revised fees, if any.</u>

The fee should be paid through a Demand Draft in favour of <u>AMITY LAW SCHOOL</u> payable at <u>DELHI</u>.
