2. The following documents are required for admission as per GGSIP University norms at the time of Counseling

- Original certificate and mark sheets of 10th, 12th Board Examinations.
- Two sets of Photocopy of the original certificates and mark sheets which will be retained by the Institution. Without this candidates will not be able to attend the counseling. (All the documents are to be self-attested.)
- Registration slip
- Admit Card of CET-2017 / proof of obtained rank as it would show the eligibility or non-eligibility (In Original).
- Proof of date of birth [(Secondary School Certificate (In Original and two Photocopies)].
- In case of students who have passed the qualifying examination through open education system of any board/institution, the necessary documentary evidence related to Location and recognition of the Board to be submitted.
- Conduct and Character Certificate in original (not more than six months old) from the Head of the Institution from where the qualifying examination has been passed.
- Certificate of Medical Fitness to be signed by a Registered Medical Practitioner holding degree not lower than MBBS in the format as given in Appendix of GGSIP University admission brochure. (Original)

Note:-

- 1. The Original Certificates (except the admit card, character certificate and medical certificate) will be returned to the candidate after verification.
- 2. In case any of the above document(s) is/ are in any language other than Hindi/English, then authentic translation in English/Hindi shall have to be produced duly verified by the issuing institution/gazette officer/ (original and photocopy) by the candidate at the time of Counseling/ Admission. Failure on the part of candidate to produce the requisite authentic translation may result in refusal of admission for which only the candidate will be responsible.
- 3. In case the Certificate has been obtained from some Board of any other country then equivalence certificate must be obtained from Association of Indian Universities (AIU) New Delhi prior to attending the counseling.
- 4. It is recommended that the outstation applicants should come with bag & baggage, in case they get the admission, they start their classes immediately as the session has already commenced.
- 5. You are not allowed to take admission in vacant quota if you have taken admission in GGSIP University counseling as per the admission brochure of 2017-18.
- 6. If you take admission in vacant quota counseling at our institute after depositing the fees and the original CET card 2017, you shall not be allowed to appear in any further rounds of counseling, if announced by GGSIP University
