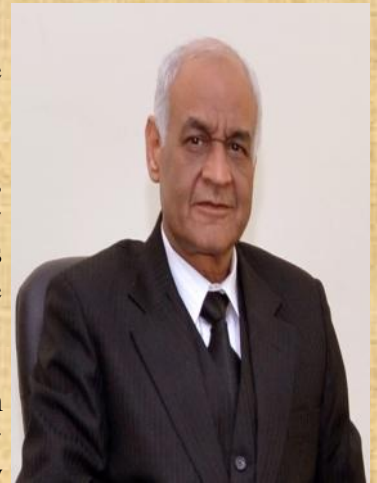

Dear Sir,

I take this opportunity to congratulate the Amity University, Madhya Pradesh, Gwalior, its School of Law including its Director and the Staff on taking the initiative in opening the “Mediation Cell” under the aegis of its ‘Legal Aid Clinic’.

Mediation of late has attained the most favoured tool to settle disputes. The Bench and the Bar alike stress the importance of settlement through mediation and try and settle the disputes wherever feasible. Hon’ble Mr. Justice SA Bobde, the Chief Justice of India, while speaking at the 3rd Edition of an International Conference at Bengaluru in first week of February 2020 on ‘ Arbitration in the Era of Globalization’ stressed the importance of a robust ‘Arbitration Bar’ is critical to the development of institutional arbitration in India. The Hon’ble CJI suggested that time is ripe to devise a comprehensive legislation that contains “compulsory pre-litigation mediation”.

The attempts made by the team of Mediators received lavish praise in the judgment.

In the present era of globalization where boundaries have become seamless and business and commercial activities have transcended borders, it is imperative to ensure efficiency in administration of justice and reduce the time of pendency and litigative expenses for parties as well as courts. Therefore, it is but natural that mediation has become the most favoured tool to settle the disputes.

Keeping the current trend in mind, the Amity University, Gwalior in right earnest has opened the ‘Mediation Cell’. It is probably a first of its kind to be accomplished by an educational institution of eminence not only to extend legal aid to the needy in this direction, but it is also to teach and train the students of the University in general and the students of law in particular in the art of mediation. It is apt that the Centre was inaugurated by Hon’ble Mr Justice Sanjay Yadav, the Acting Chief Justice of the Madhya Pradesh High Court. LEGAL AID CAMP IN CENTRAL JAIL GWALIOR

On the occasion of 70th anniversary of drafting of Indian Constitution, the awareness programme on fundamental duties of Indian Constitution are to be organized by District Legal Services Authorities , District Court Gwalior. This programme is as per the order of National Legal Service Authorities and Govt of India. Prof Dr Rakhi Singh Chouhan, HOD and Mr Arun Sharma Assistant Professor ALS are nominated as resource person for the conduct of legal aid camps by DALSA.

A legal aid camp was conducted in Central Jail Gwalior. The camp was conducted in two parts in jail- one for under trial prisoners and one for convicted prisoners. On the initiation of Dr Rakhi the appeal of both the patients is filed in High Court through Advocate of Legal Aid and the application of suspension of sentence on medical ground is initiated as well.

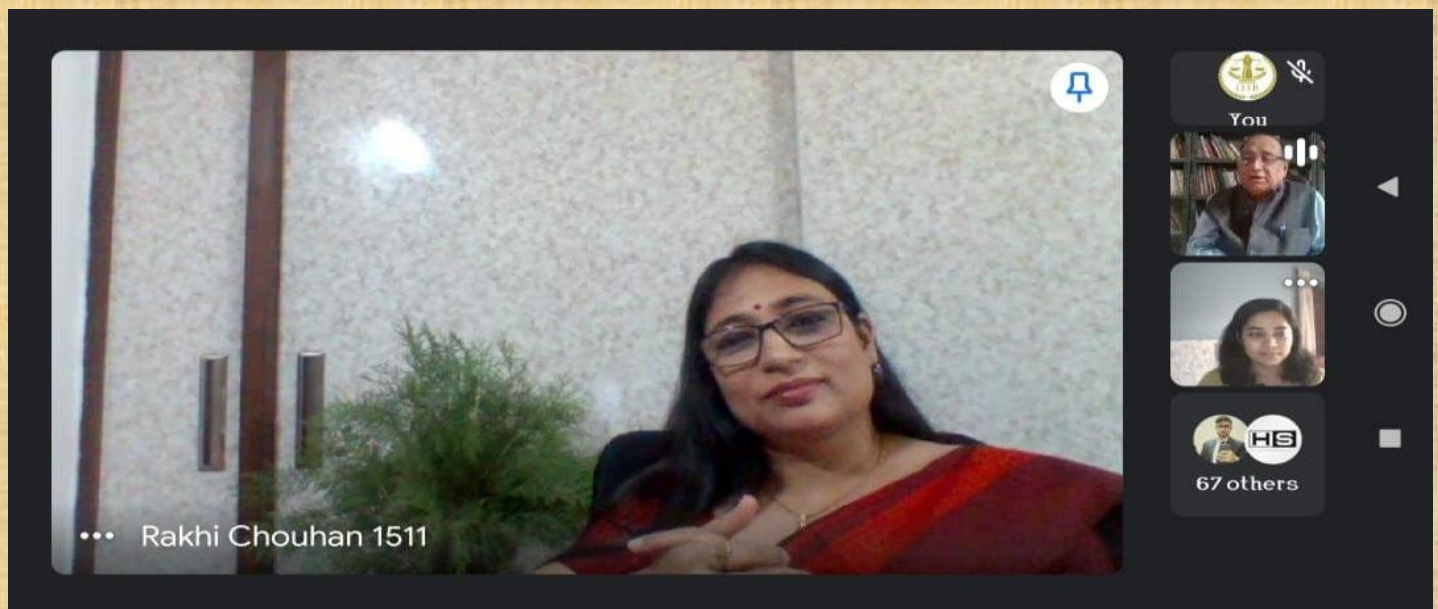
