While B.A. LL.B. is offered by most of the universities, B.Sc. LL.B. Course is offered by WBNUJS (Kolkata), NLU (Jodhpur) and GNLU (Gandhinagar). B.B.A. LL.B. is offered by NLU (Jodhpur), GNLU (Gandhinagar), CNLU (Patna) and NLUO (Cuttack); whereas B.S.W. LL.B. and B.Com. LL.B. (Hons.) degree course are offered by GNLU (Gandhinagar) alone.

Eligibility:

- To be eligible to appear in CLAT-2014, a candidate should have obtained a Higher Secondary School / Intermediate (10+2) or its equivalent certificate from a recognized Board with not less than 45% marks in aggregate.
- Candidates who are appearing in March/April, 2014 or have appeared in the 10+2 examination and are awaiting results are also eligible to appear in the test.
