Important Instructions to be adhered: -

- 1. The Re-appear schedule will be put up on the ALS-D website.
- The students are requested to ensure that they have secured <u>less than 10 marks</u> in the internal examination before appearing for the respective subject(s).
- The new PSDA projects to be submitted for the respective subjects for which they wish to give re-appear assignment.
- 4. No request for re-appear examination shall be entertained after the last due date.
- 5. The students are <u>advised to contact the respective subject faculty</u> as per details given in the schedule(uploaded on website)
- 6. The respective subject faculty will assign you a PSDA topic (15 marks) and for 10 marks, 40 marks online re-internal written examination(back) shall be conducted (40 MCQs of one mark each). The mode of examination will be through MS Forms. The respective faculty will guide you in this regard. The PSDA assignment will be evaluated by the faculty on the basis of the following parameters:
 - A) Concept clarity. B) In-depth investigation/detailing. C) Application of principles/provisions of law D) Comparative/analytical/critical aspects as per the situation. E) Evidence based reporting/references.
