#### Important Instructions to be adhered: -

- 1. The Re-appear schedule will be put up on the ALS-D website.
- 2. The students are requested to ensure that they have secured <u>less than 10 marks</u> in the internal examination before appearing for the respective subject(s).
- 3. The new PSDA projects to be submitted for the respective subjects for which they wish to give re-appear assignment.
- 4. No request for re-appear examination shall be entertained after the last due date.
- 5. The students are <u>advised to contact the respective subject faculty</u> as per details given in the schedule(attached)
- 6. The respective subject faculty will provide you the date and time (for offline mode) for conducting the examination of 10 marks.
- 7. The question paper will consists of 7 questions out of which you will have to attempt any 5 questions of 20 marks(100 marks) each that will be converted into 10 marks.
- 8. The respective subject faculty will also assign you a PSDA topic (15 marks) and its viva will be taken by him.
- 9. The PSDA assignment will be <u>evaluated by the faculty</u> on the basis of the following parameters:
  - A) Concept clarity. B) In-depth investigation/detailing. C) Application of principles/provisions of law D) Comparative/analytical/critical aspects as per the situation. E) Evidence based reporting/references.
