Implementation of order dated 18.12.2014 of Hon'ble Delhi High Court in W.P(C) 8763/2014 and CM Appl. 20120/2014.

As per orders of Hon'ble High Court in W.P(C) 8763/2014 and CM Appl. 20120/2014, the Competent Authority of the University has approved the following:

- 1. New Scheme of BALLB(H)/BBALLB(H) programmes was introduced w.e.f. academic session 2014-15. Some students who were admitted before academic session 2014-15 and were studying under old scheme introduced w.e.f. academic session 2008-09 could not get promoted to 2nd year during academic session 2014-15. These students have now been promoted to 2nd year w.e.f. academic session 2015-16 and are required to study along-with the regular batch of students admitted w.e.f. academic session 2014-15 as per the above said order of the Hon'ble High Court.
- 2. Academic session 2015-16 onwards aforesaid students would study 2nd year to 5th year of BALLB(H)/BBALLB(H) programmes under new scheme introduced w.e.f. academic session 2014-15. Apart from this these students have to also study those compulsory legal papers of 1st year under new scheme which they have not already studied in 1st year under old scheme. After comparison of both the schemes it has been observed that one compulsory law paper i.e. "Law of Torts and Consumer Protection" of 2nd Semester of new scheme has not been studied by these students.
- 3. The compulsory legal paper titled "Law of Torts and Consumer Protection" will be taught separately to the concerned students by the respective school/ institutes in the 4th Semester. The credits and paper code for this paper will be as follows:
