REPORTING OF CANDIDATE FOR VERIFICATION OF DOCUMENTS AND PAYMENT OF BALANCE FEEFOR 2016-17BATCH AT AMITY LAW SCHOOL, DELHI,

The students who have taken admission through IP University for Amity Law School, Delhi are hereby informed that they should report for verification of document and payment of balance fee at Amity Law School, F1-Block, 1st Floor, Amity University Campus, Sector-125, Noida by **24 July 2016 to 26 July 2016; 10:00 am to 4:00 pm.**

In addition to the fee of Rs. 40,000/- already paid to the IP University, <u>the students</u> are required to pay an additional amount of Rs. 41,400/-(Rupees Forty One Thousand and Four Hundred only).

The fee should be paid through a Demand Draft in favour of <u>AMITY LAW SCHOOL</u> payable at <u>DELHI</u>.

IN THE ABSENCE OF MANDATORY DOCUMENTS OF PROOF OF ELIGIBILITY FOR ADMISSION IN PROGRAMME, THE CANDIDATURE SHALL BE CANCELLED.

- 7. CONDUCT AND CHARACTER CERTIFICATE IN ORIGINAL FROM THE HEAD OF THE INSTITUTION FROM WHERE THE QUALIFY EXAMINATION HAS BEEN PASSED OR FROM GAZETTED OFFICER (ORIGINAL), NOR MORE THAN 6(SIX) MONTHS OLD.
