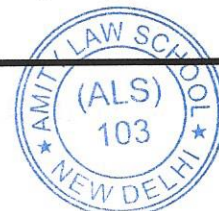


The Re-appear examination will commence from **28th August, 2019**.
