- 1. Ref. Notice dated 4-11-2019 of examination / conduct GGSIPU which states that the end term examination for all semester other than 1st Semester shall start from 18th November 2019. The said date of commencement of examination is in conformity with the University Academic Calendar ref no. GGSIPU/DAA/2019/2315 dated 11-7-2019. The proposed datasheet is also stating the same date for commencement of End Term Examination Nov.-Dec. 2019.
- 2. Ref. Notice No. GGSIPU/DAA//2019/2511 dated 1-11-2019 which states that the Academic Session has been extended to 22nd November 2019. In pursuance of this notice of GGSIP University, the ALSD had issued a notice ref. no. ALSD/Notice/2019/27 dated 3-11-2019 to effectuate the notice of GGSIPU. At the same time the notice of ALSD ref. no. ALSD/Notice/2019/26 of dated 30-10-2019 was withdrawn w.e.f 4th November 2019.
- 3. In the context of the above facts and circumstances and on the basis of new circular of GGSIPU, dated 4-11-2019, the ALSD hereby revokes its notice of dated 3-11-2019 and the ALSD notice of dated 30-10-2019 is revived.
- 4. Since, we do not have 1st semester students in ALSD, the examination of our students shall begin from 18th November 2019 (Ref. dated 4-11-2019 of GGSIPU). Further, It is hereby notified in this context that:
 - a. The remaining classes in a subject, if any, shall be conducted till 9th November 2019 in order to complete the prescribed lectures in the syllabus of that subject.
 - b. The faculty members who have completed their required numbers of lectures as prescribed in syllabus shall conduct in total 5 tutorials only vide ALSD notice of dated 30-10-2019.
 - c. The tutorial/s conducted by any faculty member on Friday dated 1-11-2019 may be counted within the prescribed limit of 5 tutorials.
 - d. Remaining lectures in Tax Law, Corporate Law, Banking & Insurance and CPC may be held 2/3 classes/ session per day w.e.f. 7th November 2019. After lunch on the same day, their tutorials may be conducted by the concerned subject teaching faculty.
 - e. The classes which have been conducted on Monday (4-11-2019), Tuesday (5-11-2019) and today (6-11-2019) in pursuance of our notice dated 3-11-2019, if they are beyond the prescribed limit of lectures in syllabus may be converted into tutorials.

It is further to clarify that 5 tutorials are proposed to be conducted in a subject.
