**ADVERTISEMENT OF *ONLINE* SHORT TERM INTERNSHIP**  
**PROGRAMME IN THE MONTH OF JUNE, 2020**

The National Human Rights Commission has expressly been mandated to promote Human Rights literacy and awareness vide Section 12 (h) of the Protection of Human Rights Act, 1993. With a view to spread awareness among College/University students about the need for protection and promotion of Human Rights, the Commission has been regularly conducting 15 Days Short Term Internship Programmes since year 1998.

2. However, as an exceptional situation that has arisen due to CORONA PANDEMIC, it has been decided that the Short Term Internship Programme scheduled for the month of June, 2020 would be conducted through online Web Platform, Web-Ex.

The ***ONLINE Short Term Internship Programme*** of 15 days would be held from **16.06.2020 to 30.06.2020**.

3. Applications for the online Short Term Internship Programme are invited from the students, who are pursuing UG, PG, etc. courses from various streams. Students from Law Stream are given preference.

4. Brief Course Structure of Short Term Internship would be

- Briefing of Members of NHRC.
- Online Classroom sessions and Interactive sessions
- Project work on Human Rights issues/ Assignments
- Book Review on books related to Human Rights issues.

5. Rules and regulations governing Internship Programme:

- NHRC does not charge any fee for the Internship. However, no Stipend is paid to the students for the Short Term Internship Programme.
- **All Students should have computing devices preferably Desktop/Laptop/Tablet with good speed Internet and properly working audio components.**
- Students who have attended earlier will not be eligible to apply.
- On completion of the Internship, Certificates will be issued on the basis of performance of intern.

6. APPLICATION FOR SHORT TERM INTERNSHIP

- (i) **THE LAST DATE** for the submission of the application for online Short Term Internship Programme of June 2020 **is 31.05.2020 upto 24.00 hrs.** All interested students are requested to kindly submit their application before the due date **and through online mode only.** The **Application Form** for Short Term Internship Programme is available at **Annexure-I.**

(ii) **Kindly note** - Incomplete applications/applications without the recommendation of the **PRINCIPAL / HEAD OF DEPARTMENT, WHERE THE STUDENT IS PRESENTLY STUDYING** are liable to be rejected. Students can send the **SCANNED** copies of the Original duly filled in applications by email at **srotrg.nhrc@nic.in**. No application will be accepted after the deadline. *It is also requested to enclose the scanned copy of **ID Card** of students.*

- Recommendation email of principal /HOD where the student is presently studying
- ID Card of Student of present College or University.
