

ACTIVITIES AND ACHIEVEMENTS – 2014-15

1. International / National Seminars and Conferences

- A National Seminar on **“Emerging Trends in Corporate Governance : Legal Issues and Challenges in India”** was organized on 11 April 2014 in which 60 Research Papers were presented by the academicians, research scholars and the students. The seminar was inaugurated by Shri B.A. Khan, former Chief Justice of J & K High Court and President SAARCLAW, India. The selected papers along with proceedings have been published in the form of a commemorative volume which has been released by the Founder President.
- An International Conference on **“Public International Law”** was organized on 11th and 12th October 2014 in which 90 Research papers were presented. The Conference was organized in collaboration with Amity International Law Association which is a student body. In this conference, 16 international delegates from 11 countries participated. The conference was inaugurated by Shri Sanjay Jain, Solicitor General of India and Mr. Gudmundur Eiriksson, Former Ambassador of Iceland to India and Mr. Narender Singh, Secretary General of Indian Society of International Law as the Guest of Honour. The seminar was inaugurated by Chief Election Commissioner of India, Shri Hari Shanker Brahma.
