The Member Secretary informed the House that no comments / suggestions had been received from any of the GB members and proposed that the minutes of the 25<sup>th</sup> GB and 48<sup>th</sup> BOM meeting be confirmed. Accordingly, the minutes were confirmed.

The Honorable Chancellor stated that Dr. Vishal Sharma is known for his expertise in higher education policy and institutional development. He invited Dr. Vishal Sharma, the esteemed DHE Nominee, to offer his valuable insights and ideas to ensure the University's continuous growth and enhancement.

Dr Vishal Sharma began by commending the University's efforts in fostering academic excellence yet emphasized that it's essential to focus on a balance between the university's current strengths, areas for growth, and alignment with state educational and economic goals. He stated that the University should focus on Implementation of sustainability programs to promote environmental responsibility, such as energy-efficient buildings, zero-waste policies, and sustainability-focused academic courses which go a long way in fetching points for the NIRF rankings.

To achieve a higher 'H' Index, the University should aspire to publish in journals with high citation metrics and broad international reach to maximize the benefits.

Dr. Vikas Madhukar also spoke about the plans to enhance the "H" Index status. He also shared with the members the STG rankings of AUH. The Pro Vice Chancellor also informed the members about the introduction of 4- year UG programs in AUH with 42 students having already opted for it.

Hon'ble Chancellor while responding to Dr. Vishal Sharma's suggestions offered to sit with him & also with Dr. Vikas Madhukar and Dr. Rajinder Prasad to evolve strategies to improve Scopus & "H" index as also to ensure brainstorming for achieving the best results for the University.

Dr. Rajinder Prasad also expressed his views about the strategies to increase 'H' index of the University. He also emphasized the need for faculty intake with research potential.

Mr. Ashish Bindra made valuable observations and suggestions for the great progress and development of the University.

Prof. Dwivedi offered his suggestions about NIRF and other rankings.

The strategic priorities of Medical College at the campus and Approach Road were discussed with Dr. A.K. Nagpal particularly contributing to it.
