2. The clinical supervisor/faculty of the DASLP of AMS would be actively involved along with the faculty/trainers of the KWS in developing the individual or group therapy plans for the children with intellectual deficits.
3. The DASLP at AUH would participate in conducting faculty advancement program for the trainers/special educators/developmental therapists of the KWS.
4. The DASLP would like to be involved in the material development, awareness, promotional, vocational, and research activities addressing the specific need of the children with intellectual deficits.
5. The DASLP along with other departments of the Amity Medical School such as clinical psychology, optometry, and dentistry would conduct screening and diagnostic camps periodically to evaluate whether children with special needs may have associated impairments.
6. The ASLP students (Bachelors and Masters) would join clinical supervisor/faculty in developing therapeutic plans and executing those activities on the children with intellectual deficits.
7. The posting profile of the BASLP and MASLP students will be decided jointly by the faculty/supervisor of the DASLP and the KWS, satisfying the need and interest of the children with special need and according to the course curriculum of the ASLP students.
8. The mutual collaboration will come into effect on the date signing this MOU by the DASLP and KWS. It will be valid initially for three years. The collaboration would be periodically reviewed between the parties from time to time, and it can be extended as per mutual agreement.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made, entered and executed into on 26th Day of November, 2020.

BY AND BETWEEN

Public Health Foundation of India, India (hereinafter referred to as the “PHFI”), a Society registered under the Indian Societies Registration Act, 1860 having its registered address at Unit No. 316, 3rd Floor, Rectangle -1 Building, Plot No. D-4, District Centre Saket, New Delhi-110017.

“PHFI” Party of the First Part

AND

Amity University Haryana (hereinafter referred to as the “AUH”), having its registered office at Amity Education Valley, Gurugram (Manesar), Haryana-122413

“AUH” Party of the Second Part

Whereas both **PHFI** and **AUH** will be individually referred to as a “Party” and collectively as the “Parties”.

1. PARTNER BACKGROUND.

- A. The **PHFI** is a response to redress the limited institutional capacity in India for strengthening education, training, research and policy development in the area of Public Health through its network of 5 Indian Institutes of Public Health located at Delhi (NCR), Hyderabad, Bhubaneswar, Shillong and including one Indian Institute of Public Health University at Gandhinagar (Gujarat).

B. The **AUH**, a University established under the Government of Haryana vide Haryana Act Number 10 of 2010, is a research and innovation driven, not for Profit University making a difference in the lives of academic aspirants. The University is built on the foundation which embodies attributes that have made Amity Institutions world-class over the last two decades. With each passing year, Amity has instituted global standards in education, training and research with state of art infrastructure and the latest teaching methodologies.

2. COMMON OBJECTIVES

PHFI and AUH want to work jointly to promote education & research. This MoU outlines the broad framework of understanding between the two parties by identifying areas of cooperation. The objective of this collaboration as defined in the MoU is to stimulate quality public health education and training, implement scientific and cultural exchange, and promote inter-institutional cooperation. The two parties will develop and foster education, training, research & professional activities involving projects among students and faculty of the institutions.

3. SCOPE OF MOU

Within the scope of this MoU, PHFI and AUH agree to conduct the following activities. However, the terms and conditions for conducting these activities mentioned below will be agreed upon through separate and specific agreements.

- 3.1. Exchange of faculty members for conduction of teaching, training, and participation in programs / projects;
- 3.2. Exchange of faculty members for lectures, talks, conferences, seminars, symposia and sharing of ideas for enrichment of academic programme offerings of either institute.
- 3.3. Exchange of students for field visits and internships.
- 3.4. Exchange of academic information and materials of interest.
- 3.5. Exchange of scientific and educational literature produced by either or both parties.
- 3.6. Conduct joint research activities and publications. The topics and conditions for utilizing the results, and other forms of co-operation will be determined on a case by case basis by the researchers and administrators of each party.

4. BUDGET

Implementation of each activity mentioned in Clause 3 of the MoU shall be subject to the availability of the required funds for the activity. Specific financial agreements will be executed between both parties on finalization of activities under this MoU. It is understood that neither party has any financial obligation to other party under this agreement.

5. GOVERNANCE

- 5.1. In order to support the development of this collaboration, both parties agree to review the progress of their collaboration every six (6) months.
- 5.2. An Advisory Committee will be formed based on the recommendations of PHFI and the AUH. This committee will regularly review the progress of the collaboration.

6. INTELLECTUAL PROPERTY RIGHTS

Any material developed through activities pursuant to this MoU will be the joint property of both PHFI and AUH. Any such material may be disseminated by a party only after obtaining prior written consent of the other party.

7. CONFIDENTIALITY

- 7.1. Each party shall undertake to maintain the confidentiality of the documents, information and other data received from the other party during the period of implementation of this MoU or any other agreement made pursuant to this MoU.
- 7.2. Both parties agree that this article shall continue to be binding between the parties notwithstanding the termination of this Mo U.
- 7.3. This is exclusive of those cases in which disclosure of such confidential documents or information is mandatory under prevailing laws.

8. FORCE MAJEURE

In the event of either Party not being able, by reason of force majeure, to meet any of its obligations under this MoU, such obligation shall be suspended for as long as the inability continues or any date mutually agreed between the Parties, provided that Party gives to the other Party written notice within fourteen (14) days after the occurrence of any such event.

- i. Neither Party shall be liable to the other Party for any loss or damage sustained by the other Party arising from the occurrence of any such event.

- ii. The term 'force majeure' as employed herein shall mean an event not within the control of either Party which, by the exercise of due diligence, neither Party is able to overcome and this, includes any act of God, strike, lockout or other industrial disturbance, wars, insurrections or riots, civil disturbances as well as explosions.
- iii. Either Party may terminate this MoU at any time, by notifying the other Party of its intention to terminate this MoU by a notice in writing six (6) months prior to its mention to do so.
- iv. The termination shall not affect the implementation of on-going activities/programmes, which have been agreed upon prior to the date of the termination of this MoU

9. LIABILITY

9.1. Both PHFI and AUH shall be solely responsible for any and all claims and/or damages in connection with the exercise of its objectives hereunder.

9.2. Both parties further agree that no employment relationship or partnership, either express or implied, is created between them.

10. DISPUTE RESOLUTION

10.1. In the event of any dispute relating to the interpretation or performance of this MoU arising between the Parties, both Parties will first do their utmost to settle their dispute amicably.

10.2. This is a cooperation MoU only and the parties do not intend to commence litigation or arbitral proceedings against one another in the event of any dispute, claim, misunderstanding, differences, interpretation or controversy.

11. DURATION OF MOU

The MOU would be effective for a period of 5 years from the date of signing it. It may be extended after expiry of such period and on such terms and conditions as may be mutually agreed upon.

12. CONFLICT OF INTEREST

Both Parties warrant that this MoU is not likely to have any conflict of interest with any of their organizational, financial, contractual or other interests relating to the activities under this MoU.

13. AMENDMENTS

13.1 Either Party may request in writing for a revision, amendment or modification of all or any part of this MoU.

13.2 Any revision, amendment or modification agreed to between the Parties shall be in writing and shall come into force on such date as determined by the Parties and shall form part of this MoU.

14. TERMINATION

14.1. Either Party may terminate this MoU at any time by means of at least 90 calendar days' written notice to the other Party.

14.2. The early termination of this MoU will not affect the completion of any co-operation measures that were agreed under the annual work programmes whilst it was in force.





MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is signed between:

Amity Institute of Clinical Psychology (AICP), Amity University Haryana, Near Manesar, Gurugram, Haryana (AUH)

AND

Lokopriya Gopinath Bordoloi Regional Institute of Mental Health (LGBRIMH), Tezpur, Assam (LGBRIMH).

The Lokopriya Gopinath Bordoloi Regional Institute of Mental Health, (hereinafter referred to as "LGBRIMH") at Tezpur, Assam provides patient care services in the field of Mental Health, development of manpower in Psychiatry, Psychiatric Social Work, Clinical Psychology and Psychiatric Nursing. The Institute extends community services under District Mental Health Programme / National Mental Health Programme and provides specialized training to UG (Nursing) and PG students, trainees and research workers of other institutions.

NOW THEREFORE AICP AND LGBRIMH have intended, agreed and consented to the following terms and deeds for clinical posting and training of students in LGBRIMH.

- 1.1 Currently AICP will place currently 1 no of students for short term training for 30 days.
- 1.2 LGBRIMH, having the professional skills and trained human resources, will take responsibility for imparting necessary exposure training to students posted in LGBRIMH.
- 1.3 Presently AUH student Ms. Akshaya Atreya Enrolment No- A51340816007 studying MSc Clinical Psychology (Semester-2) 2016-18 batch will agree to pay a sum of Rs. 1000 to LGBRIMH towards Training Fee per student for up to 15

days/ Rs. 2000 for 16-30 days. The training fee may be revised /enhanced at any time by LGBRIMH.

- 1.4 The students will be placed for short-term training /exposure only once in their total course tenure.
- 1.5 The exposure training will be given as per convenience and current posting schedule of LGBRIMH.
- 1.6 The posted students will maintain Institute's decorum and will abide by and comply with the academic rules and regulations of LGBRIMH and in the event of violation of institute norms by the students, LGBRIMH will have the authority to expel the student at any time during training period. In case of expulsion, no portion of training fee will be refunded.
- 1.7 LGBRIMH will not provide any accommodation to trainees due to paucity of hostel. However, when hostel accommodation will be available, trainees may avail the facility on payment of accommodation and food charge as payable under Hostel rules.
- 1.8 Trainees will not be allowed to take any photograph of patient either from indoor or outdoor. Any breach will be regarded as misconduct and this may lead to expulsion of the student.
- 1.9 Both the parties shall evolve a mutually acceptable schedule for training.
- 1.10 The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the parties of MOU.
- 1.11 The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.
- 1.12 The intent and implementation of this memorandum is SUBJECT to the policies of the Govt. of India and the laws of the land.
- 1.13 The MOU shall remain in force for a period of 3 (three) years from the date of its signature and seal, and may be terminated by either side by giving a month's

notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

1.14 Dispute if any will be resolved through negotiations.

1.15 All legal matter will be within the jurisdiction of the Tezpur Court.




PREAMBLE

Whereas Amity University (AUH) is a part of the Amity Education Group, Amity offers varied course in different areas and is now initiating courses in the areas of Clinical Psychology, Social Work and other Mental Health allied areas.





PURPOSE

Amity University, Haryana has approached Vimians to start with a joint venture

RESPONSIBILITY AREAS


- a) AUH shall be responsible for delivery of lectures and conducting examinations.
- b) AUH shall be responsible for recruiting faculty both full time/ part time for the programmes.
- c) VIM would send its faculty to deliver certain lectures desired for some courses from time to time at AUH, mutually agreed upon between both the parties from time to time
- d) Conducting all theory and contact classes shall be the responsibility of AUH.
- e) AUH shall be responsible for managing the programmes and for co-ordination and management of student admission/ enrolment.
- f) AUH would be responsible for the award of the degrees, diplomas and certificates as the case may be.
- g) Providing all academic infrastructure including student facilities etc. and accommodation if required will be the responsibility of AUH.
- h) The practical and / or clinical training would be conducted at VIM. Division of practical/ clinical training will be decided by mutual agreement between both the parties from time to time.
- i) Commuting & transportation of the students of AUH, or if required by faculty of VIM, shall be facilitated by AUH.
- j) VIM may consider offering internship and full time placement to the student of the program run jointly. It is understood by both the parties that



VIM doesn't in any way guarantee the job placement for the qualified students.

- k) Both parties may conduct joint research project, symposia, conference, seminars and scholarly meeting, on mutual agreement.
- l) AUH is to recruit and appoint a minimum of 2 clinical supervisors with minimum qualification of Clinical Psychology M.Phil from an RCI recognised institute along with clinical work experience.
- m) The clinical supervisors would be required to be available at VIM on days of placement. Their responsibilities would include:
Active monitoring of attendance/regularity/punctuality of placed students as well as ethical execution of their clinical responsibilities.
- n) Referrals will be made from Psychology/ Rehabilitation/Psychiatry departments of VIM to the clinical supervisors, who will ensure their fair distribution among the posted students. All clinical services provided to the referred clients would be on a free of cost basis.
- o) AUH would ensure adequate availability of core test material and to procure the same as and when necessary.
- p) The clinical supervisor would be responsible for supervising cases referred to them for assessment and therapy. Additionally, it is desirable that they also be familiar with core tests to supervise their administration, scoring and report writing.
- q) The clinical supervisors would be welcome to attend and participate actively in all academic activities at VIM. They are also welcome to attend rounds/grand rounds in the Inpatient Department.
- r) AUH will collect the entire fee from the student and VIM will be compensated for their role in the teaching/training/ mentorship programs, on mutually agreed terms and conditions as finalized between the parties from time to time.

s) VIM will ensure regular/adequate clinical referrals from departments of Psychiatry, Psychology (child and adult) and Rehabilitation.

Referrals will be of two kinds:

- i. Diagnostics including assessments
- ii. Therapy including outpatient and inpatient referrals.

(t) The students would have postings of 2-3 months on rotation basis across IPD/OPD (child/adult/rehabilitation departments).

(u) The students would be given exposure to OPD/IPD activities including attending rounds/grand rounds.


(v) The students shall be clinical observers for case history.


(w) The students shall participate /contribute in non pharmacological intervention activities for inpatients and family, including Positive Activity Intervention (PAI):

- i. Art
- ii. Music
- iii. Group discussion
- iv. Mind Body
- v. Involvement in family psycho education and self help groups in areas of substance abuse and schizophrenia

(x) The students shall receive participation/training through academic activities on mutually decided upon number of days (1-6) a week. In the form of :

- i. Psychology academic meets (Monday/Tuesday)
- ii. Interdisciplinary case conferences (Wednesday/ Thursday)
- iii. Academic seminar, journal clubs, guest lecturers (Friday)
- iv. Workshops/Public Lectures






- (v) Theme based clinical supervision would be provided by a Clinical Psychology professional (from Child/Adult department) at VIM, 2 hours per week on rotation basis chargeable on a mutually agreed basis. Examples of core areas focused on would be Child Psychology, Adult Psychology (Psychotic and Neurotic Spectrum disorders), Neuropsychology and Rehabilitation, etc.
- (xi) VIM would offer inputs / guidance / supervision to AUH students for organizing delivery of Mental Health services to the needy at and around AUH by mutual consent.
- (xii) Vimhans reserves the right to admit Non PG / PG interns/ students under its own internship programs as it has been doing for past 15 years.

IMPLEMENTATION


The designated coordinators shall be nodal officer to oversee and facilitate the implementation of this MOU. The Coordinators so appointed by both the parties will be responsible for jointly executing the terms of agreement as well as to formulate curricula and modules for the various courses and for addressing all issue related to this collaboration. The two coordinators will meet frequently and they will gradually structure the clinical training as per the requirements and mutual agreement. In case of any deadlock the same shall be referred to the top authorized officials of both the parties or their authorized representatives, who will collectively decide on resolving the deadlock in a time bound manner.

The coordinators will also periodically evaluate, audit and review the progress of the academic/clinical programs, and give their recommendations with a view to work out improvement in operation, as and when required.

Number of students to be posted from AUH for clinical internship at VIM shall be decided by mutual discussion and agreement.








