2. The agendas of the meeting included the following: -

(a) Approval of the syllabus of course work in Ph.D. Law for the batch 2021-2024 (Full time) and for the batch 2021-2025 (Part time).

- (c) Recommendation of the syllabus of LL.M (One Year) for the batch 2021-2022.
- (d) Recommendation for Discontinuation of B.Com.LL.B.(H) Programme.
- (e) Recommendation of the syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) for the batch 2021-2026.
- (f) Recommendation of Curriculum for LLB (H) Three Year Degree Course Programme for 2021-24 Batch.
- (g) Recommendation of Curriculum for CBCS in IPR and Human Rights programmes 2021-24 Batch.

3. Recommendations.

After in-depth analysis of existing course structure of various courses of ALS, AUMP and prevailing course structures in other Universities, Board unanimously made following recommendations:-

I. Recommendations for Ph.D. Course work

Board recommends to adopt the syllabus adopted in the BOS 2020 for the Batch 2020-23 (Full Time) for batch 2012-24 (Full Time) and for the Batch 2020-24 (Part Time) for batch 2021-25 (Part Time) as it is, in terms of Courses, Course contents, Credits, Marks and Examination schemes.

II. Introduction of New LLM (Two year) Programme

In light of the recent notification of BCI regarding PG programmes in Law, Board recommends to introduce a new LLM(Two Year) Programme with Specialisation in Constitutional and Administrative Law, Business Law and Criminal Law for the batch 2021-23. The Proposed Course Structure of New LL.M. (Two Year) Programme is as under:-

IV. <u>Recommendations for B.A.LL.B.(H)</u>, <u>B.B.A.LL.B.(H)</u> and <u>B.Com.LL.B.(H)</u> programmes

- a. Board recommends discontinuing the B.Com.LL.B. (H) Programme, hence, to remove its syllabus including all of its Courses.
- b. Board recommends changing the credits of BAL/BBL 403 Communication Client Interviewing Counselling and Advocacy Skills from 2 to 4, being core subject.
- c. Board recommends removing the Module VII Juvenile Justice (care and Protection Act) from the syllabus of BAL/BBL/BCL 503 Criminal Law –II Code of Criminal Procedure. Rest of the Syllabus of BAL/BBL/BCL 503 Criminal Law –II Code of Criminal Procedure shall remain same in Course Code, Content, Credits, Marks and Examination Schemes.
- d. Board further recommend to Remove BAL/BBL 913 Offences against women and Children and replaced it with New BAL/BBL 913 "Offences related to Juvenile" with same Course Code, Credits, Marks and Examination Schemes, as contained in Annexure III
- e. Board also recommend to replace the BAL/BBL 1002 "Equity and Trust" with a new Course "International Trade Law" in course title and contents, with same Course Code, Credits, Marks and Examination schemes as contained in **Annexure IV**.
- f. Board further recommends to adopt the rest of the syllabus of B.A.LL.B.(H), and B.B.A.LL.B.(H) programmes adopted for the batch 2020-25, for the coming Session 2021-26, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of B.A.LL.B.(H) and B.B.A.LL.B.(H) programmes, adopted for the batches 2021-26 is annexed herewith and marked as <u>Annexure III, IV</u> and <u>V</u> respectively.

IV Recommendations for LL.B.(H) Programme:

a. Board recommends removing the Module VII Juvenile Justice (care and Protection Act) from the syllabus of LLB 302 Criminal Law –II Code of Criminal Procedure. Rest of the Syllabus of 302 Criminal Law –II Code of Criminal Procedure shall remain same in Course Code, Content, Credits, Marks and Examination Schemes.



- b. Board further recommend Removing LLB 513 Offences against women and Children and replaced it with New LLB 513 "Offences related to Juvenile" with same Course Code, Credits, Marks and Examination Schemes, as contained in <u>Annexure III</u>
- c. Board also recommend replacing the LLB 604 "Equity and Trust" with a new Course "International Trade Law" in course title and contents, with same Course Code, Credits, Marks and Examination schemes as contained in Annexure IV.
- d. Board recommends adopting the rest of the syllabus of LL.B.(H) programme adopted for the batch 2020-23, for the coming Batch 2021-24, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of LL.B.(H) programme, adopted for the batches 2021-24 is annexed herewith and marked as **Annexure V.**

V Recommendations for CBCS Courses

Board recommends discontinuing the CBCS in Public Administration from the next Academic Session 2021-22. Board further recommend to adopt the syllabus of CBCS in IPR and Human Rights adopted for the batch 2020-23, for the coming Batch 2021-24, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of CBCS in IPR and Human Rights programmes, adopted for the batches 2021-24 is annexed herewith and marked as **Annexure VI, VII** and **VIII** respectively.
