1. A meeting of Board of Studies of Amity Law School, Amity University Madhya Pradesh was held on 29th Jan 2018 at 1100 hrs at AUMP, under the Chairmanship of Maj. Gen. Rajinder Kumar, AVSM, SM, VSM (Retd) Director, ALS. Following members attended the meeting:-

2. **The agendas of the meeting included the following: -**

- (a) Approval of the syllabus of course work in Ph.D. Law for the batch 2018-2021 (Full time) and for the batch 2018-2023 (Part time).
- (b) Approval of the syllabus of LL.M for the batch 2018-2019.

(c) Approval of the syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) for the batch 2018-2023.

(d) Approval of New Curriculum for LLB (H) Three Year Degree Course Programme for 2018-21 Batch.

3. **Recommendations.**

After in-depth analysis of existing course structure of various courses of ALS, AUMP and prevailing course structures in other Universities, Board unanimously made following recommendations:-

I. **Recommendations for Ph.D. Course work**

Board recommends to adopt the syllabus of Ph.D. Course work in Law for 2017-18, for the coming Session 2018-19, as it is. The Course structure and the Syllabus of Ph.D. Coursework, adopted for the Session 2018-19 is annexed herewith and marked as **Annexure I.**

II. **Recommendations for LL.M. (One Year) Programme**

Board analysed the syllabus of one year LL.M. (One Year) Programme prevailing in Amity University M.P. for the Session 2017-18 and compared it with the Course structures of leading Universities and found it appropriate in course structure, contents and credits, however, some necessary changes are required. Thus the Board recommends as follows:-

- a. Board recommends to add another specialization to the syllabus of one year LL.M. Course considering the prevalence of popularity of this specialization in this area. The new specialization will be in “**Criminal and Security Law**”.

The Course structure for the **Criminal and Security Law** specialization with Course Code and Credits is proposed as under:-

- b. With the approval of Hon^{ble} Vice Chancellor, LLM 141 Advance Communication, LLM 241 Communication for Employment, LLM 144 French I and LLM 244 French II have been removed and new Examination Scheme has been introduced for LLM 143 Behavioral Science I and LLM 243 Behavioral Science II. The BOS recommends to ratify the changes made on the directions of the Hon^{ble} Vice Chancellor. Copy of the proposal to the above effect and direction of the Hon^{ble} Vice Chancellor is annexed herewith and marked as **Annexure II**.
- c. Board further recommend to adopt the rest of the syllabus of LL.M. for 2016-17 for the coming session 2017-18 as it is.
- d. The Course structure and the Syllabus of LL.M. (One Year), adopted for the Session 2018-19 is annexed herewith and marked as **Annexure III**.

III. **Recommendations for B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes**

The present syllabus contains 3 specializations, in B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes. The Board analysed local requirements and compared the existing course structure with the course of various leading Universities, and made following recommendations:-

- a. Board recommends to add another specialization to the syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes considering the prevalence of popularity of this specialization. The new specialization will be in **“Crime and Criminology”**.

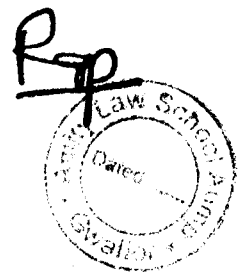

- b. In existing Syllabus of 2017-22, the Course BAL/BBL/BCL 803 Taxation Law is included in 8th Semester of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes, whereas the tax laws are amended every year in the month of February-March, it, therefore, becomes difficult to incorporate the amended law in the course curriculum during the Even Semester, hence it is found appropriate to keep it in an odd Semester. The Course BAL/BBL/BCL 803 Taxation is recommended to be replaced by BAL/BBL/BCL 901 Professional Ethics; However, Except the Code, contents and Credits will remain unchanged.

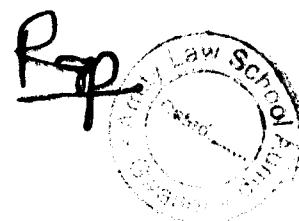


- c. In existing Syllabus of 2016-21 and 2015-20, the Course BAL/BBL/BCL 802 Taxation is included in 8th Semester of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes, for the reason stated above, so it is difficult to incorporate the amended law during the Even Semester, hence it is found appropriate to keep it in an odd Semester, Hence, the Course BAL/BBL/BCL 802 Taxation is recommended to be replaced by BAL/BBL/BCL 904 Professional Ethics, which will become BAL/BBL/BCL 802 However, except the Code, contents and Credits will remain unchanged.
- d. The Code of BAL/BBL/BCL 506 Administrative Law is recommended to be changed to BAL/BBL/BCL 404 in existing syllabus for 2016-21. Earlier the subject was taught in IV Semester only. Eventually it was shifted to V Semester for no apparent reasons as no record is available. Status quo to be restored with a view to balance the load of teaching in both the semesters.
- e. The existing Syllabus for 2016-21, 2015-20, 2014-19 and 2013-18 BAL/BBL/BCL 001 „Legal Writing“ is recommended to be modified to “Legal Writing (Dissertation)” with same course code, course structure and course contents and credits. Reason for the said amendment is to make clear that the legal writing is “Dissertation”
- f. The Course structure and the Syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes, adopted for the session 2018-19 is annexed herewith and marked as **Annexure IV**.

IV Recommendations for LL.B.(H) Programme:

LLB (H) programme is being introduced first time Hence, after analysing existing curriculum in various Universities specifically Delhi University and Punjab University and other Institutions, this Board prepared a new curriculum based on BCI Guidelines and keeping in mind the local requirements. BOS made following recommendations:-


- a. All the courses will be divided into seven categories viz. “Core Courses ” (basic subjects of law, mandatory for all students), Clinical Courses (Compulsory as per BCI



Guidelines), "Mandatory Courses" (Practical Courses), Basket Elective Courses (compulsory optional courses) "Specialised Courses" (Specialised courses for Hons. Courses) NTCC (Non Teaching Credit Courses) and "Value added courses" (Courses, introduced by AUMP to add additional values to the courses.

- b. As per BCI Guidelines for LL.B.(H) programmes and UGC guidelines for Hons Programmes, the Board proposes 4 groups of optional courses i.e. "Business Law", "Intellectual Property Law (IPR)", "International Law" and "Crime and Criminology". Students have to opt one group for specialization for Hons. Courses in "Specialized Courses". "Basket Elective Courses" provide options to the students from the given courses of law, to meet out the requirement of BCI rules of 6 elected courses, from the given Categories from II Semester onwards.
- c. All the course Codes have been assigned as per the existing subject codification system prevailing in AUMP.
- d. Credits for the "Core Courses" (basic subjects of law, mandatory for all students), Clinical Courses (Compulsory as per BCI Guidelines), Basket Elective Courses (compulsory optional courses) "Specialised elective Courses" (Specialised courses for Hons. Courses) courses will be 4 in all semesters.
- e. Credits of Mandatory courses in all Semesters will remain 1 (One).
- f. Teachers are free to adopt required teaching pedagogy for the law courses, however, it is expected to include Class Room Exercises (CRE) wherein the students will be given a case every week to submit memorials on the case and present the case in the moot court. The evaluation of the same will be done taking into consideration the files submitted by the students and the oral presentation.
- g. In all the courses, the students shall be required to prepare projects assigned to them during classes and the same shall be required to be presented in the student seminar/symposium/workshop.

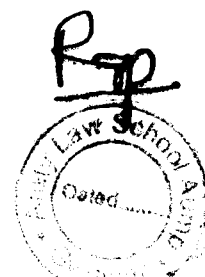


- h. The Course structure and the Syllabus of LL.B.(H), programmes, adopted for the Session 2018-19 is annexed herewith and marked as **Annexure V**.

V Recommendations for CBCS Courses

As per mail of Dean (Academics) dated 25/01/2018, course structure of CBCS Courses are directed to be restructured. Accordingly, all three CBCS courses are recommended to be restructured. The Board recommends that:-

- a. Course structure of CBCS in IPR is recommended to be amended and IP 5105 Nature and concept of Trademarks and IP 5106 Geographical Indications of Goods merged together and a New Course with Code IP 5105 and title Trademark and Geographical Indications will replace them having 4 Credits.
- b. A New Course IP 5106 is recommended to be introduced with Title "Project Work" with 1 Credit.
- c. Credits of IP 5104 Patents & Patent Law in India are recommended to be increased to 4 from present 3.
- d. Course structure of CBCS in Human Rights is recommended to be amended and HR 5203 Universal Declaration of Human Rights and HR 5204 International Covenants on Human Rights are recommended to be merged together and New HR 5203 will be introduced with Title Universal Declaration and International Covenants on Human Rights with credit 4 instead of 3 (Three).
- e. Course HR 5205 International Refugee Law and Humanitarian Law will become HR 5204 and HR 5206 Human Rights in India will become HR 5205. Credits for new HR 5204 International Refugee Law and Humanitarian Law are recommended to be increased to 4, instead of previous 3 (Three).



- f. A New Course HR 5106 is recommended to be introduced with Title "Project Work" with 1 Credit.
- g. Course structure of CBCS in Public Administration is recommended to be amended and PA 5306 Evolution of Indian Administration is recommended to be replaced with a new Course PA 5306 with Title "Project Work" and with 1 Credit.
- h. Credits for PA 5304 Administrative Law and PA 5305 Personnel Administration are recommended to be increased to 4 instead of 3 (Three).
