- 1. A meeting of Board of Studies of Amity Law School, Amity University Madhya Pradesh was held on 17th January 2020 at 1400 hrs at AUMP, under the Chairmanship of Maj. Gen. Rajinder Kumar, AVSM, SM, VSM (Retd) Director, ALS. Following members attended the meeting:-

2. The agendas of the meeting included the following: -

- (a) Approval of the syllabus of course work in Ph.D. Law for the batch 2020-2023 (Full time) and for the batch 2020-2024 (Part time).
- (b) Approval of the syllabus of LL.M for the batch 2020-2021.



- (c) Approval of the syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) for the batch 2020-2025.
- (d) Approval of Curriculum for LLB (H) Three Year Degree Course Programme for 2020-23 Batch.
- (e) Approval of Curriculum for CBCS in IPR, Human Rights and Public Administration programmes 2020-23 Batch.

3. Recommendations.

After in-depth analysis of existing course structure of various courses of ALS, AUMP and prevailing course structures in other Universities, Board unanimously made following recommendations:-

I. Recommendations for Ph.D. Course work

Board recommends following changes in the syllabus of Ph.D. Course work in Law (Full Time) for batch 2020-23 and of Ph.D. Course work in Law (Part Time), for batch 2020 – 2024:-

- a. In compliance of the amended UGC Guidelines, a new Course with the name "Research & Publications Ethics" is proposed to introduce in Ph.D. Course work in Law (Full Time) for batch 2020-23 and of Ph.D. Course work in Law (Part Time), for batch 2020 2024 with the course code PRP 102.
- **b.** Course PHDLW 103 "Recent Trends in Law" is recommended to remove from the syllabus in compliance of the amended UGC Guidelines.
- c. Codes of various courses for Ph.D. Course work in Law (Full Time) for batch 2020-23 and of Ph.D. Course work in Law (Part Time), for batch 2020 2024 are recommended to amend in furtherance of mail of COE dated 30/01/2020. The new course codes are PRM 101 for "Research Methodology", PRP 102 for "Research & Publications Ethics" PRL 103 for "Review of Literature" and LAW 104 for "Comparative Constitutional Law".
- **d.** Credits for LAW 104 Comparative Constitutional Law" are recommended to increase from 3 to 4 for Ph.D. Course work in Law (Full Time) for batch 2020-23 and of Ph.D. Course work in Law (Part Time), for batch 2020-2024.



e. Board of Studies further recommend that the rest of the syllabus of various courses for Ph.D. Course work in Law (Full Time) for batch 2020-23 and of Ph.D. Course work in Law (Part Time), for batch 2020-2024 shall remain as it is in terms of course structures, course contents and credits. The amended Course structure and the Syllabus of Ph.D. Coursework, adopted for the Session 2019-20 is annexed herewith and marked as **Annexure I**.

II. Recommendations for LL.M. (One Year) Programme

Board recommends to adopt the syllabus of LL.M. (One Year) 2019-20, for the coming Session 2020-21, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of LL.M. (One Year), adopted for the Session 2019-20 is annexed herewith and marked as **Annexure II**.

III. Recommendations for B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes

- a. Board recommends that in light of the recent amendments in company law the words "Statement in lieu of Prospectus" be removed from Module II and the words "Compromise, Arrangement and Amalgamation" be added in Module IV of Course BAL/BBL/BCL 605, Company Law.
- b. Board further recommends to adopt the rest of the syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes adopted for the batch 2019-24, for the coming Session 2020-25, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of B.A.LL.B.(H), B.B.A.LL.B.(H) and B.Com.LL.B.(H) programmes, adopted for the batches 2020-25 is annexed herewith and marked as <u>Annexure III, IV</u> and <u>V</u> respectively.

IV Recommendations for LL.B.(H) Programme:

Board recommends to adopt the syllabus of LL.B.(H) programme adopted for the batch 2019-22, for the coming Batch 2020-23, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of LL.B.(H) programme, adopted for the batches 2020-23 is annexed herewith and marked as **Annexure V**.



V Recommendations for CBCS Courses

Board recommends to adopt the syllabus of CBCS in IPR, Human Rights and Public Administration programmes adopted for the batch 2019-22, for the coming Batch 2020-23, as it is in terms of course structures, course contents and credits. The Course structure and the Syllabus of CBCS in IPR, Human Rights and Public Administration programmes, adopted for the batches 2020-23 is annexed herewith and marked as **Annexure VI, VII** and **VIII** respectively.
