MINUTES OF THE MEETING OF ACADEMIC COUNCIL OF AMITY UNIVERSITY MADHYA
PRADESH, HELD ON 12TH MARCH 2020

1. The 16th meeting of the Academic Council of Amity University Madhya Pradesh (AUMP) was held on 12th March 2020 at 1100 hours at the Amity University Campus, Maharajpura, Gwalior (M.P.). The meeting was held under the Chairmanship of Lt Gen V K Sharma, AVSM (Retd), the Vice Chancellor, AUMP, Gwalior.

2. The Agenda Points proposed to be discussed during the meeting, were earlier circulated to all members and are attached as Appendix-A. The list of Members of Academic Council of Amity University Madhya Pradesh present in the meeting is attached as Appendix-B. The Academic Council then proceeded to discuss the agenda points. The details of discussion are given in the succeeding paragraphs.


3. Agenda No. 1: Welcome Address by Chairman.

(a) The Vice-Chancellor of the University and Chairman of Academic Council welcomed all the members of Academic Council. He informed members that the aim of the Academic Council Meeting is to plan for next semester commencing from July 2020. During his address he informed the members about the UGC letter received in r/o taking precautionary measures against Corona Virus (COVID-19) and 'Say No To Drugs'. The Vice Chancellor informed the members that AUMP is strictly complying with the advisory issued by the UGC. He informed the members that he has already instructed Director (Admin) to take appropriate measures against COVID -19, and to Chief Proctor & Director (Hostel) to formulate an Action Plan for 'Say No to Drugs'.

(b) The Vice Chancellor issued the instructions to cancel all the upcoming events like, Seminar/Conference/Workshops/ Meetings etc. planned during the m/o March and April 2020.

(c) The Vice Chancellor informed all the Hols that IIQA of NAAC has already accepted by NAAC and we have to submit the Self Study Report (SSR) latest by 10th April 2020. He informed that as 10th March 2020 is a Holiday, we have to submit the SSR on 9th April 2020. He requested all Hols to prepare their departmental presentation and make their own departmental SSR, as Hon'ble Chancellor may visit to see the presentation/preparation any time. He also requested all Hols to include all research publications, projects, patents etc those are in pipelines also in the SSR so that research part of SSR can be made more marks oriented. He requested all Hols to ask the concerned

faculty members to proactively liaison with the funding agencies and keep continue follow-up with them.

(d) The Vice Chancellor directed all to maintain the records of all the data pertaining to SSR and make it presentable for any of the inspection team.

(e) The Vice Chancellor said that the NAAC inspection will be carried out for all the programmes shown in the IIQA. All Hols must prepare and ensure the availability adequate facilities like infrastructure, labs, consumables, faculty and staff, books & journals etc.

(f) The Vice Chancellor directed Offg. HoI, AIBAS to prepare for inspection to be carried by RCI for starting new course i.e. PG Diploma in Rehabilitation Psychology and do mock rehearsal of the same.

4. **Agenda No. 2: Ratification of Minutes of Academic Council Meeting held on 20th September 2019 and Circular Resolution dated 17th December 2019.**

(a) The Minutes of the last Academic Council Meeting held on 20 September 2019 were briefed to the members. The minutes were ratified and are attached as **Appendix - C**.

5. Ordinance No. 51 - PG Diploma in Hospital Management



(d) The Vice Chancellor said that all changes made in the syllabus, credits, course structure etc should be communicated to CoE and should also be uploaded on Amizone.



The requirement of Library books duly recommended by Library Committee was put up before the members of the Academic Council for approval. The same was approved and is attached as Appendix- J.



(d) The letter of UGC in this regard is attached as Appendix - O.




