
Whereas, Amity Institute of Biotechnology is a constituent of AUMP and as such part and parcel of the AUMP.

- Faculty members of Amity Institute of Biotechnology, AUMP, Gwalior will attend the conferences/symposia/trainings/meetings on JKG Sustainable Development Foundation, Delhi, request. The expenditure for travel, boarding/lodging and registration will be met by JKG Foundation.
- Acknowledge JKG Sustainable Development Foundation in publications of research carried out by funding provided by JKG Sustainable Development Foundation, Delhi.
- Apply for collaborative projects in different funding agencies.

Resolution of any dispute:

Any dispute arising out of interpretation of any provision of MOU or otherwise shall be resolved amicably through arbitrator appointed by and acceptable to both the sides.

Amendment, tenure and termination:

This MOU can be amended only by a written consent duly signed by the authorized signatories or their successors. The MOU between AUMP, Gwalior and JKG Sustainable Development Foundation, Delhi will come into effect from the date of signing by both the parties after getting approval from the competent authorities. The parties acknowledge and agree to fulfill requirements and to undertake all activities identified under this MOU. The MOU will be valid for two years, which may be extended for further period as agreed between both the parties. The confidentiality maintaining period will be of two years, from the date of expiry of MOU. Any party may terminate the MOU by providing six months written notice to other party.
