#### **General**

1. Intellectual Property Rights are legal rights governing the use of creations of the human mind. The recognition and protection of these rights is of recent origin. Patents, designs and trademarks are considered as industrial property. As per International Convention for the protection of industrial property (Paris Convention) the protection of industrial property has its object Patents, Utility Models, industrial designs, Trademarks, Service Marks, Trade names, Indications of source or appellations or origin and the repression of unfair competition when Copyrights, Geographical indicators, Layout Designs and confidential information were included to industrial property, they all become intellectual property. Amity Business School in association with Consortium of Women Entrepreneurs of India (CWEI) conducted a National seminar on "Intellectual Property Rights" on 29th July, 2019 in the Seminar Hall, Block C of the University to create a forum for discussion over this contemporary topic. CWEI is accredited by Govt. of India and is a Member of National Board, Ministry of MSME and is working closely with Ministry of Rural Development. Several distinguished guests from academic and industry background made their presence felt and participated in the programme to share their ideas, views and experiences on identified topics in the above area, like, intellectual property rights, copyrights, patents, fostering women entrepreneurship using IP tools, facilitation & systems of protection of IPR tools, trademarks and brand building etc.

#### **Objective(s) of the Seminar**

- 2. The National Seminar was organized with following objectives:
- (a) To create awareness amongst participants, students, scholars and faculties about the importance of intellectual property rights, copyrights patents & trademarks etc.
- (b) To facilitate interaction among experts of IPR organizations, researchers, and academia.
- (c) To explore thrust areas of research in this contemporary field.
- (d) To provide a networking opportunity to participants, scholars, students, faculties and experts.
- (e) To provide a platform to participants, experts & faculties to showcase their knowledge.
- (f) To foster Brand building of ABS and AUMP as a premiere educational Institution.
- (g) To enhance industry-academia network of AUMP Gwalior.

#### **Pre – Seminar Outcomes**

#### 3. Tangible Outcomes

- (a) The Seminar attracted a fair amount of attention from Experts & Educationists in the field of Intellectual Property Rights and Entrepreneurship Development. More than 100 students of AUMP Gwalior and various experts in the field of IPR attended the seminar.
- (b) Rs. 8,300/- were contributed by CWEI and Rs 5,000/- were received against the sponsorship in this seminar.

#### 4. Intangible Outcomes

- (a) The media campaign, conducted prior to the conduct of the event resulted in wide coverage of the seminar by all leading newspapers. This has resulted in branding of Amity University.
- (b) The National Seminar was vigorously advertised on the social media as well as in number of important social platforms such as Facebook and Whatsapp. A large number of persons who would have seen these posts would have got a very positive impression about ABS in particular and AUMP in general.
- (c) Strong association was developed with Consortium of Women Entrepreneurs of India (QWEI) which will further help AUMP in future.

#### **During Seminar Outcomes**

#### 5. Tangible Outcomes

- (a) Five eminent speakers (as per Appendix-I) from different domains of intellectual property rights were invited. They enriched the sessions with their vast knowledge. Participants and students of ABS were benefited by their deliberations.
- (b) In his inaugural address, Hon'ble Vice Chancellor, Lt. Gen. V.K. Sharma AVSM (Retd.) gave a brief illustration on the evolution and development of IPR around the globe in general and in India in particular. He also elaborated on the rights of the patentee with special reference to the application of law on the violation of IPR rights.
- (c) Dr. Shashi Singh Chairperson CWEI, spoke about Fostering women entrepreneurship using IP tools. She said that IPR is a tool to strengthen the innovation and ancient art. She also analyzed the patent laws with reference to international treaties and conventions and explained that in order to obtain patent for an invention it has to pass triple test of novelty, non-obviousness and usefulness. The same was discussed at length with the procedure of filing patent application.
- (d) Dr. Jyoti Choithani Ramani, Senior Associate, KNS Partners was one of the key note speakers during the Inaugural Session. Dr. Ramani delivered her lecture on Overview of IPR. She covered introduction to various forms of Intellectual Properties, types of Patents & Design which comes under IP act in India. Patents include both technical and legal information. She told that in order to perform good and useful search, it is essential to understand the structure of patent information, whatever form it can take as well as where and how to use the available search tools.
- (e) Ms. Sweta Rajkumar, Asst. Controller of Patents, IPO delivered her keynote speech on Facilitation & Systems of Protection of IPR tools. She explained the process of filing & registration of Intellectual Property in India. She gave various examples in Indian Scenario to explain the importance of filing patents for any new product or innovation. She gave emphasis on the need of IPR protection and informed the audience about the various conventions and treaties. In addition to this she also gave an overview of the mechanism for filing of the patent application and emphasized on the importance of the date of filing the same.

(f) Ms. Ankita Aich, Examiner, Copyrights, Intellectual Property India delivered her keynote speech on

copyright act and various technical aspects of copyrights. She also informed about Online Copyright

Registration i.e. E-filing and the working of the same. Through her talk she explained how patent

searching is very useful for several purposes not only for organizations and universities, but also for

researchers. She explained the timeline, process and legal requirements of copyright and also

covered various tangible and intangible advantages of Copyrights.

(g) Ms. Anumita Verma, Examiner, Trademarks, Intellectual Property India addressed the students on

the topic Trademarks and Brand Building. She also covered various ethical and non-ethical practices

which we encounter in our daily life with respect to use of registered properties under IP act.

(h) Students and faculty members of AUMP, approx. 100 persons attended the seminar.

(i) As per policy of the University all the relevant documents were recorded and kept for future

reference of faculty, scholars and students.

6. <u>Intangible Outcomes</u>

(a) National Seminar resulted in knowledge sharing by experts from various areas of intellectual

property rights in the form of key-note speeches. The experts presented innovative ideas and

concepts related to IPR in various sessions. This has resulted in enhancement of knowledge of

faculty, students, participants and delegates.

(b) Knowledge was disseminated not only to the students of ABS but also to other students of AUMP

who attended the Conference.

(c) The technical sessions amplified the awareness on various diversified issues related to copyrights,

patents and trademarks that have increased knowledge and awareness among the students, research

scholars and faculty.
