


**General Terms of the Agreement**

- a) The Agreement will come into effect on the date of signing and shall remain valid for three (03) years. It may be further renewed by mutual agreement in writing.
- b) Amendments and additions may be made to the agreement by written Addendum signed by both parties.
- c) Financial obligations with regards to programs and exchanges will be discussed and agreed upon separately by the parties.
- d) The modalities, funding & financial arrangements of any activities arising from this agreement will be jointly agreed upon in writing by both parties.
