
# MEMORANDUM OF UNDERSTANDING (MoU)

## ARTICLE II: SCOPE OF INVOLVEMENT

- a. Educational exchange- Faculty and Students of AUMP and members of Crossroads Clothing Pvt Ltd will enter into specific exchange programs agreed upon by individual departments and faculty.
- b. Research- Each of the party is free to enter into one or more of the individual or joint work projects.
- c. Training and internship- The students of AUMP will be assisting merchandisers/designers of Crossroads Clothing Pvt Ltd. The faculty of AUMP would also supervise them as internal faculty guide for programme.

# ARTICLE III: MODALITIES OF COOPERATION

A committee comprising of faculty members from AUMP and Crossroads Clothing Pvt Ltd will be responsible for setting up & implementing the envisaged cooperative academic and research activities.

# ARTICLE IV: PROGRAMME MANAGEMENT

Their will be a regular review for progress of all activities carried out under this MOU atleast twice in an year. This MOU can be amended only by a written consent duly signed by the Parties. The MoU for collaboration between the said AUMP campus and crossroads clothing pvt ltd will come into force after getting approval from the competent authorities.

## ARTICLE V: LIMITATION OF LIABILITY

No party to this MOU shall accept a liability or responsibility nor assert a claim, right or interest against the other party for damages or any loss arising from activities under this MOU.

#### ARTICLE VI: DURATION OF AGREEMENT

This MOU becomes effective from the date when signed by both the parties and will be valid for a period of two years. Any party may cease its cooperation under this MOU by providing six months' written notice to the other party.

This MOU is a statement of intent of the parties to cooperate and is not legally binding upon the parties under any circumstances, whatsoever. This MOU does not create legally enforceable rights, claims,

or obligations in favor of either of the Parties, as against the party.
