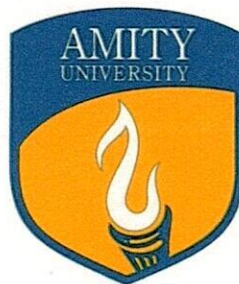



This document serves as a memorandum of understanding between

AMITY UNIVERSITY MADHYA PRADESH (AUMP) established by Ritnand Balved Education Foundation (RBEF) vide Madhya Pradesh Government Legislature Act of 2010 with the view to promote professional, industry-oriented education in the state of Madhya Pradesh. Amity University Madhya Pradesh Located on sprawling campus of 102 acres of land opposite Gwalior Airport, imparts modern, practical and research-oriented courses which will lead to the development of professionals who are employable and industry ready. This in turn will drive the socio-economic uplift of the region. Amity University Madhya Pradesh imparts education in almost all areas including management, engineering, architecture, biotechnology, law, communication, behavioural science, fine arts, fashion etc.

The University was awarded "Utkrisht Vishwavidyalaya Samman" by Madhya Pradesh Private University Regulatory Commission, Bhopal in 2018. The University has bestowed with 'Excellent University Award 2020' by Zee News. AUMP has been awarded a Five Star Rating under "Eat Right Campus" Competition conducted by Food Standard, Safety Authority of India under the aegis of "Eat Right India" campaign launched by Govt, of India. 
NOW THEREFORE THIS AGREEMENT WITNESSETH AS FOLLOWS:

Responsibilities of Edu Brain Overseas:

1. Edu Brain committed to share best Internship program & placement opportunity to university as per the academic Calendar.
2. Edu Brain will decide to get the internship application forms of the Institutions/College/University/Hotel.
3. Edu Brain will assists the Student in filling-up application forms for internship program along with all the necessary documents preparation and submission to get smooth visa for them.
4. Edu Brain will forward the completed applications and all other documents to the Institutions, through the Foundation, in one lot. Edu Brain will bear the courier/postal counseling expenses for the same.
5. Edu Brain will undertake all correspondence with the Institutions, till the receipt of the result from the institutions/employer.
6. Edu Brain will hand over all the admit letters, visa and forms received at Edu Brain's office in the Student name to students or institution.
7. Edu Brain will take care of smooth visa & boarding process of students till the time of immigration clearance at airport.
8. Edu Brain will provide complete assistance for Airport pick and drop to students with all local rules and regulation in respective country.
9. Edu Brain is authorized to publish the details of International Internship and Placement done by Edu Brain of the University.

Responsibilities of AUMP :

1. The Student of Amity University Madhya Pradesh shall fill up the International Application Form along with separate declaration forms in favor of (Edu Brain overseas) authorizing them to keep in touch with the Institutions in order to secure admission and negotiate for financial aid on Student's behalf. This will be based on purely voluntary basis.
2. Amity University Madhya Pradesh understands and agrees that the Edu Brain Overseas role is to present materials solely for educational purposes, and not to provide clinical supervision to course attendees.
3. Both Parties shall not be held liable or responsible for damages or injuries arising out of the actions of course attendees due to their Misbehavior at the Hotel/ Company / College during a session or thereafter.
4. Therefore, the student of Amity University Madhya Pradesh knowingly and voluntarily, with the intention of binding to the institute any suit or action at law or in equity against Edu Brain Overseas, its agents, employees, contractors, by reason of any claim of damages or injuries arising out of the actions of course attendees during a session or thereafter and will indemnify and hold harmless the CONSULTANT will not be liable for any such activities by student. On the similar line's reciprocity will apply in favor of Amity University Madhya Pradesh wherein EDU Brain Overseas and/or its staff, agents, advisors etc. indemnify Amity University Madhya Pradesh against any claim or damages of any nature.


In case of any emergency occurring during the tenure of the Internship or the placement of the student the first Contact would be their respective employer in which they are Interning or placed and the second Contact would be Edu Brain Overseas or Amity University Madhya Pradesh.

No Financial Commitment Clause

This MOU is not a commitment of funds or any other financial implications. Financial commitment will depend on type or program or option selected by Amity University Madhya Pradesh. Separate work/ service-related agreements will be signed between Amity University Madhya Pradesh and Edu Brain Overseas with financial clause.

Dispute Jurisdiction and Resolution:

Any and all differences and disputes whatsoever arising between the institutions shall in the first instance be resolved mutually between the institutions and in the event of a non-resolution, the matter may be referred to arbitration to a person jointly appointed by the institutions as per the law relating to





arbitration in India and the decision of the arbitrator shall be final and binding. The arbitration proceedings shall be held in Amity University Madhya Pradesh, Gwalior

Renewal, Termination and Amendment


This Memorandum of Understanding shall remain in force for a period of three (3) years from the date of the last signature, with the understanding that either party giving written notice to the other party in any year may terminate it. The agreement may be extended by mutual consent of the two parties.

This Memorandum of Understanding may be amended by written amendment signed by the authorized persons at each institution.


For the purposes of this memorandum of agreement encompassing specific programs between Amity University Madhya Pradesh and Edu Brain Overseas it is understood and agreed that neither party shall be liable for any act of negligence, either of commission or omission, chargeable to the other, unless such liability is imposed by law.
