1. Agenda Item No. 1: Welcome by the Chairman

3. Agenda Item No. 3: Academic Support

The following points related to the academics were discussed:

3.1. Classroom Lectures

3.1.1 On subject of Academic Support, Ms Apoorva Agrawal of B Tech (CSE) requested that more power plug points be provided in all classrooms so that the students may recharge their laptops. The Chairman assured her that the point would be raised with Admin

3.1.2 Mr. Harshit Agrawal of MBA requested that the students be given more access to the IT Lab in C Block the Chairman assured her that the point would be raised with the IT Dept.

3.1.3 CSE Girl student proposed that the Aptitude Test Training be started in the V Sem as opposed to the current practice of VI Sem. She was informed that the University is going to launch a Cluster based training from II Sem onwards from the Academic Session July 2019.

3.1.4 Mr Anuj wanted that the information regarding the Incubation Center be made available to all the students so that more students would be benefitted from its mentoring. The Chairman agreed to circulate the said information to all concerned.

3.1.5 Mr Harshit was of the opinion that Speakers should be installed in all Classrooms so that Videos lectures could be played. The Chairman assured him that the point would be raised with Admin.

3.1.6 All the students requested that one is a year Industrial Visits should be organized. It was agreed to discuss the matter with all concerned.


3.1.7 Mr. Gajendra Singh of B.Tech (MAE) wanted that a Common Indoor Sports Room be made available to the students The Chairman assured his that the point would be raised with Admin


3.2. Library

4. Agenda Item No.4: Infrastructure: Inputs on

4.1 Classrooms

4.1.1 Almost all the students requested that greater attention be paid to maintenance of the Classrooms like broken furniture, dirty curtains etc. The Chairman agreed to discuss the matter with Admin

4.1.2 Students of Block A also said that the staff was in the habit of arbitrarily fixing responsibility for the breakage and did not try to ascertain facts. The Chairman promised to speak to the staff to be more cautious in their approach in fixing responsibility.

4.2 Cafeteria and Mess

4.2.1 Students of A and C Block complained of insufficient stock in the cafeterias and even in B Block, few healthy options were available. Block A cafeteria was short staffed also, leading to long waits and mismanagement. The Chairman promised to look into the matter

4.2.2 The students complained of the Kuchha Parking in B and C Block, leading to many cases of flat tyres. The Chairman assured that the point would be raised with Admin

5. Placements

5.1.1 Regarding Pre-Placement Training, the students suggested that the Training start in V Sem only instead of VI Sem so that they can perform better in their Internship Interviews. She was informed that the University is going to launch a Cluster based training from II Sem onwards from the Academic Session July 2019 onwards

5.1.2 Students of Civil and Bio Tech raised a request that core companies of their domain does not visit the campus for placements. The matter would be communicated to CRC.


6. Agenda Item No 6: Any other item with the permission of the chair


The students raised the following points with reference to scholarships:


- i. Merit scholarship is given only if the class size is 30 +. As such no matter how well a student performs in some courses such as Bio Tech where the total intake is 30, the student would never gain a scholarship.
- ii. A student who is given a scholarship at the time of admission continues to get scholarship if s/he maintains a minimum CGPA. However, a student of the same class who did not get scholarship at the time of admission does not get scholarship later, even if his/her scores are better than the other student getting scholarship.
- iii. Academic Excellence prizes are not given on the Stage during Raising Day if the batch size is less than 10.
- iv. The students requested that the information regarding the availability of Nursing Assistants in the various blocks be widely circulated. The Chairman agreed to circulate the said information to all concerned.

The students were assured that the matter would be discussed with competent authorities.





4. **Agenda Item 01: Welcome address by Chairperson- Students' Council**

The Hon'ble Dy Pro Vice-Chancellor of the University and Chairperson of Students' council opened the proceedings with his welcome speech. Following a formal welcome to all members of the Students' Council, the chairman explained the purpose, relevance, and responsibilities of the student council members.

5. **Agenda Item 02: Academic Support: Students' inputs to be sought on Classroom Lectures, Library, and Students Club**

(i) Classroom Lectures:


Students of ABS and ALS raised the issue of their full day engagement in the university due to which they are not able to join coaching classes for preparation of competitive exam. Replying to this issue, Hon'ble chairman assured them to discuss it with the concerned HOIS for more insight and take steps accordingly.

Students of ALS department shared his view on the curriculum and suggested to avoid the repetition in the curriculum. In response to his view, chairperson informed to the council that as a part of our routine practice, all the departments revise their syllabus every year.

(ii) Library:

Number of surveying and research related books are less in AIB, ALS and ABS. Other than that Student of ABS department suggested that we could include Research related books, which will be useful in various types of dissertations

- (iii) **Co – curricular / Extracurricular Activities:** Activities such as annual cultural festival, SANGATHAN, AMICHRAMA several literature events and competitions, fine arts and creativity competitions, student exhibitions led by students are conducted annually. It also includes dance festival orientation events amongst others. poetry, dance, musicals, etc are also conducted. The council also goes on to serve the purpose of organizing co-curricular activities, workshops, seminars and technical events and skill based workshops. As a part of the social awareness initiatives, under the aegis of NSS programs in health awareness, distribution of clothes, food, books etc and awareness activities like nukkad natak on cancer day, Anti-tobacco day, Justice Day, Language Day are also organized.
- (iv) **Cafeteria and Mess:** Students from the 'A Block' and 'B Block' complained about the cafeteria and mess. The students complained of the following issues about the mess :

- Menu is not followed properly,
- The quality of food is very poor.
- Mess register is not properly maintained.
- Drinking water in mess is not regularly checked. Inadequate Seating arrangement especially when there is a common mess for girls and boys.

The students were informed that Director- Administration had addressed all the Hostel students recently for the said issues & a University Duty Officer checks the menu, quality of food, infrastructure etc twice a week to ensure quality & improve the system.




