ABOUT THE SEMINAR

The conceptual fuzziness of Terrorism is not just a scholarly issue but one with the serious consequences for the concepts of sovereignty and integrity of a nation as well as protection of Human Rights.

Combating terrorism has become more complex because it is based on secrecy principle, the type and intensity of violence, the place of occurrence, the capacities of the actors and the timings of terrorist acts are unknown. The intervening States therefore, act on the basis of doubts and some uncertain predictions. Even if the latter turn out to be true because of sound intelligence, they will inevitably also lead to a large suspect list. Further to distinguish terrorists from innocent people means permanent control on danger to humanity since Terrorism is admittedly a crime against humanity. This justifies State intervention expanding to social, economic and financial domains. Given the secrecy and uncertainties surrounding Terrorism, the fight can hardly be targeted. As a result, the freedom of intervention of the State increases. In such an environment, the intelligence/ security agencies collect informations about the political, social, financial and economic lives of citizens. Such kind of anticipated intervention to fight against Terrorism leads to Human Rights activists raising issues of Human Rights. Considering the changing facets of Terrorism like State-sponsored Terrorism, cyber, biological and other forms of Terrorism and the secrecy principle involved in it, combating it to protect the Human Rights of innocent persons has become increasingly difficult and complex.

Amity Law School, Amity University M.P. is Organising a one day National Seminar in an effort to provide a forum to discuss the various facets of Terrorism, its effect on Human Rights and difficulties to counter Terrorism on **24 March, 2018**.

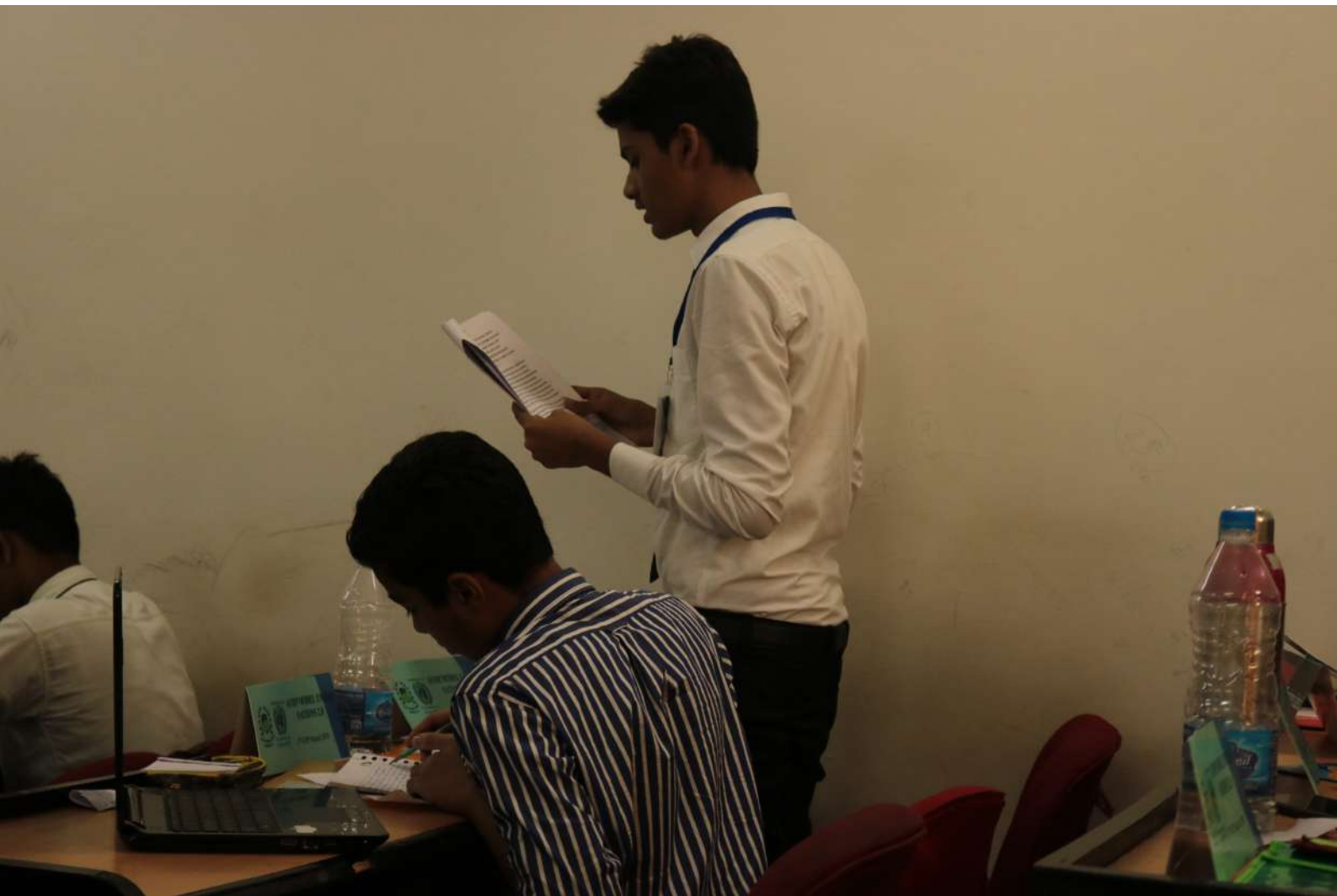

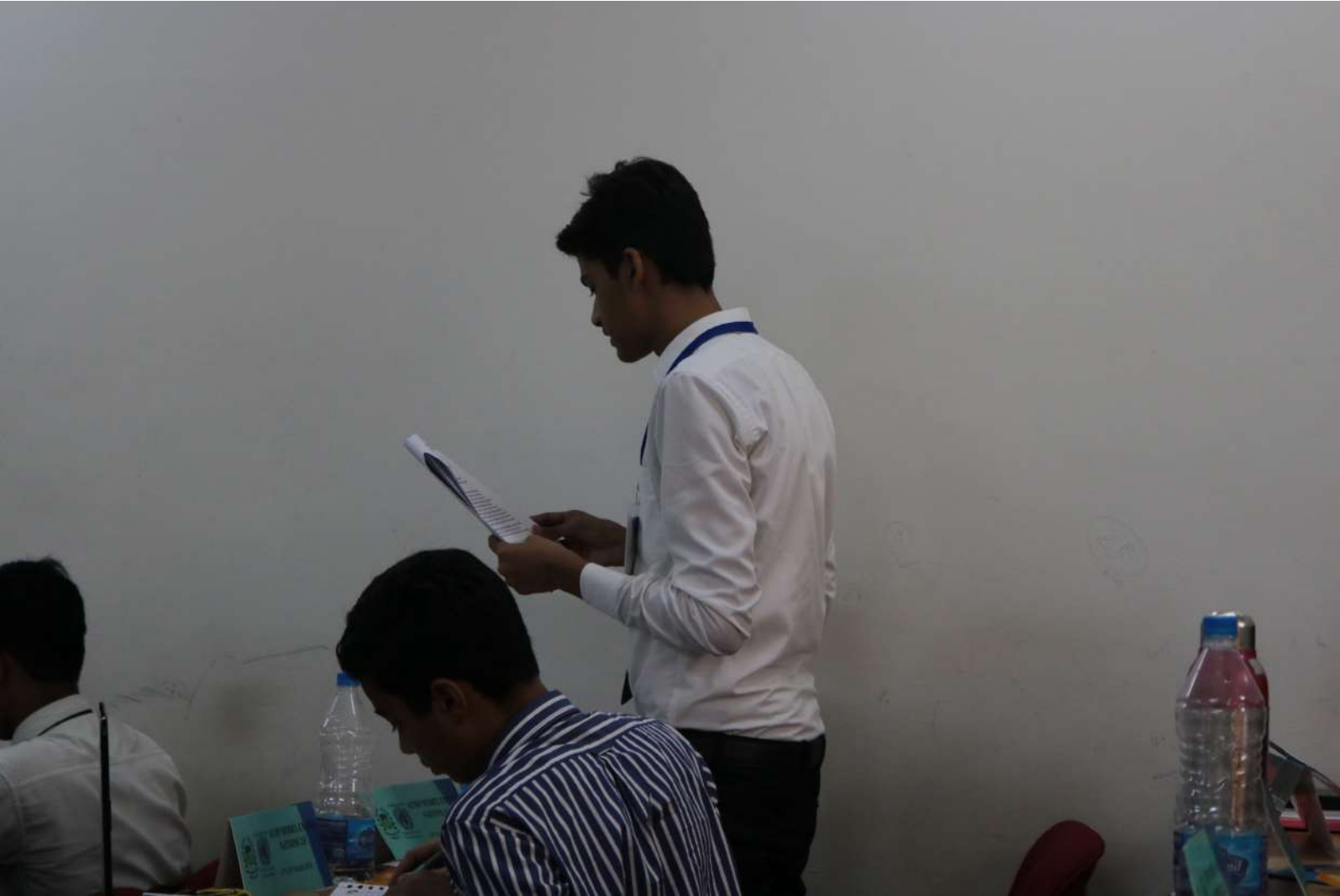

General

1. Life of law is not logic, it is experience. Hence, Practical experience in law is very important. When stands in good stand with any legal professional, Moot Court exercises are indispensable to impart practical training to the students of Law. In the above backdrop, Amity Law School, Amity University, Madhya Pradesh, Gwalior conducted an internal Moot Court Competition, “4th INTRAMOOT 2018” for its own students. All the UG students of ALS, except first and Final year students, were required to actively participate in the event. 1st year students, however, were also required to take part as the Court clerks and as spectators. The Competition was organized on 24-26 October 2018 in ‘B’ Block, Amity University, Madhya Pradesh, Gwalior, with an intention to give a platform to budding lawyers for growing as a skilled professionals. The Moot Proposition was based on Constitutional Law. The issue was related to Article 14, 19 and 21 of the Constitution of India. Faculty members of ALS judged various rounds of the events. LL.M. students were also included in the panel. Students were examined on three Parameters, First, they were examined for their drafting skill through their Memorials for Petitioner and Respondent, thereafter, researchers of the participating teams were examined for the research they did for the event in relation to Moot Proposition. The ultimate test was the arguments before the Court. Out of 55 teams of 3 students each, 8 teams qualified for quarterfinal round on the basis of their collective marks in Memorials and 1st Oral round. Through knockout rounds, two teams reached the Final. After conducting various rounds in Room No. 106, 107, 108, 109, 110, 204-A and 204-B, the final was organized in the Moot Court.

Objective (s) of the Moot Court Competition

2. The Moot Court Competition was organized with the following objectives:
 - a. To impart practical training to the students about the court proceedings and to handle legal problems in a methodical and meticulous manner.
 - b. To teach the students to carryout research to find solutions to a legal problem.
 - c. To enable the students to learn the art of applying law to the given facts and present arguments before the court in clear, concise and logical manner.
 - d. To train the students about the Court etiquettes and court craft to enable them to make persuasive arguments.
 - e. To encourage the students to make best endeavours by honest, dispassionate, scientific, critical and careful investigation, enquiry and search to discover legal principles by taking into account the legislation, executive and judicial law making process. Further it is also designed to assess how far the legal process serves the social needs, and how it could be made useful and effective for the public good.
 - f. To teach the law students honesty of purpose, industrious engagement rendering justice as a judge and helping to render justice as an advocate, serving the society and philosophical free thinking and solving legal problems independently.
 - g. To enable the students to excel in law, consequently testing their creativity and powers of persuasion in a friendly competition.
 - h. To motivate the students to excel in interpretative skill which in fact is the lifeline of law.
 - i. To create an atmosphere of Moot Court in the ALS.

Pre – Event Outcomes

3. Tangible Outcomes.

- (a) All students from 3rd, 5th and 7th Sem of all courses of ALS participated in the event.
- (b) 1st sem students of UG Courses also participated as Court Clerks and spectators.
- (c) 55 teams of 3 students each participated in the event.
- (d) Total 187 students including 155 competitors, 8 Organizing Committee members and 24 Court Clerks of 1st Sem of UG Courses took part in various capacity in the event.

4. Intangible Outcomes.

- (a) Students of ALS got an opportunity to prepare the memorials based on the ‘Moot Proposition’, which sharpened their drafting skill in relation to a real life issue.

- (b) Arguments on the given issues in Moot Court enhanced their arguments skill before the Court and they got well-versed with the court etiquettes and court craft.
- (c) Students got an opportunity to hear the arguments advanced by other teams on this very topic and views of Judges, which strengthened their knowledge and understanding of the subject.
- (d) Students learnt to carry out the research to find relevant law to the facts of the case.

During Moot Court Competition Outcomes

5. Tangible Outcomes.

- (a) Students participated in the moot court as budding lawyer and argued their cases with refreshing clarity converted into proper courtcraft.
- (b) Certificates were given to every participant, which shall be a part of their record, thereby establishing the name of AUMP forever.
- (c) As per the policy of the University, all the talks were recorded and kept in the Library for future reference of faculties, scholars and students.

6. Intangible Outcomes.

- (a) INTRAMOOT resulted in knowledge sharing by young budding lawyers of ALS in the form of high quality arguments. The participants presented innovative research ideas while arguing. This has resulted in enhancement of knowledge of students.
- (b) Knowledge was disseminated not only to the students of ALS but also to other students of AUMP, who attended the Moot Court.
- (c) The various rounds amplified the awareness of the students on various diversified issues related to the Moot Proposition that increased research skills among the students, research scholars and the faculties.
- (d) The Arguments in Moot Proposition also enhanced the knowledge of faculties and students as well as research scholars. Exposed them to new research ideas, which credibly enhanced the reputation of AUMP as a research and innovation driven University.

AUMP NATIONAL MOOT COURT COMPETITION 2018

6th & 7th September 2018

1. General

Amity Law School (ALS) – Amity University Madhya Pradesh organised a AUMP National Moot Court Competition 2018 on 6th and 7th September 2018 at B Block Amity University MP Gwalior, with an intention to give a platform to budding Lawyers for flowering them as skilled professionals. The Moot Proposition Prepared by Dr. Sandeep kulshrestha was based on Mumbai Attack and thereafter a hypothecated surgical strike by in Indian army in POK, where an accused of Mumbai Attack was caught, who challenged his arrest and detention on various legal grounds. 18 teams from all corners of India participated in this second edition of National Moot Court including 5 National Law Universities. The dignitaries who graced the event included Former Judge of High Court and District Court, and Advocates of High Court of M.P. who judged various rounds of the events, shared their ideas on this contemporary topic and their experiences while dealing with the related matters, Teams of Punjab University, Chandigarh and UPES University, Dehradun reached into final where both the teams argued their viewpoints before a bench comprising Hon'ble Justice B.K. Dubey (Retd), Shri G.C. Dubey Former Registrar General of M.P. High Court and Mr. Manoj Shahi, Advocate. Punjab University Chandigarh Won the second edition of AUMP National Moot Court.

A cultural eve was organized on 6th September. Valedictory ceremony was conducted on 7th September. Chief Guest in valedictory function was former Judge of M.P. High Court Hon'ble Justice B.K. Dubey (Retd), whereas Shri G.C. Dubey Former Registrar General of M.P. High Court and Mr. Manoj Shahi, Advocate were the guest of honour of the event.

- e. To motivate the students to give excel to their wings of creativity, specifically in the field of law.
- f. To create an atmosphere of Moot Court in the ALS.

3. Pre –Event Outcomes

3.1 Tangible Outcomes

- a. The Moot Court Competition attracted the attention of the Institutions and the academicians from every part of the country.
- b. 36 Institutes enquired about the events.
- c. 22 teams registered themselves, whereas 18 teams actually participated in the event.
- d. Five teams of various National Law Schools were also participated in the event.
- e. Rs. 51,000/- received against Registration Fees from the participating teams.

3.2 Intangible Outcomes.

- a. Vide scale publicity was done through various websites, Social media, correspondence and other sources in various Law Schools throughout India. This massive publicity helped to establish the brand AUMP.

- b. Law Octopus, Jus decree and Law Seekho were associated with the event as Sponsor and gave the prizes to the winners, which can be converted into a long term relationship with these leading legal websites having wide base in India.
- c. The Moot Proposition was related with the interest of every Indian citizen and at the same comprising serious legal issues. Students from every corner of the country argued on this very topic and judges also discussed their views. Students of ALS got an opportunity to hear the experts on the issue, which strengthened their knowledge and understanding of the subject.
- d. Memorials submitted by various teams are assets to the Law library.

4. During Event Outcomes

4.1 Tangible Outcomes.

- (a) Former Judge of M.P. High Court namely Hon'ble Justice Shri B.K. Dubey Former Registrar General of Madhya Pradesh High Court Shri G.S. Dubey Judged the Final Round and graced the event as Chief Guest and Guests of Honour during Valedictory session. They appreciated our efforts. Other Guests including Advocates of M.P. High Court also very much impressed with the efforts made by ALS.
- (b) Certificates were given to every participant and Mementoes were given to every participating team, which shall be a part of their record, there by established the name of AUMP forever.
- (c) As per the policy of the University, all the talks were recorded and kept in Libraries for future reference of faculties, scholars and students.

4.2 Intangible Outcomes

- (a) National Moot Court resulted in knowledge sharing by young budding lawyers of various institutes in the form of high quality arguments before experienced Advocates and Hon'ble Judges. The participants presented innovative research ideas while arguing. This has resulted in enhanced knowledge of students and delegates.

- (b) Knowledge was disseminated not only to the students of ALS but also to other students of AUMP who attended the Moot Court.
- (c) The various rounds amplified the awareness on various diversified issues related to the Moot Proposition that increased research skills among the students, research scholars and the faculties.
- (d) The Arguments in Moot Proposition also enhanced the knowledge of faculties and students as well as research scholars, exposed them to new research ideas, which credibly enhanced the reputation of AUMP as a research and innovation driven University.
- (e) Participation of eighteen teams from the renowned institutions throughout the country, manifested the reach of ALS, AUMP in the country.

5. Post Event Outcomes

5.1 Tangible Outcomes.

- (a) The event was covered by eleven leading newspapers/ news-sites including Dainik Bhaskar, Patrika, Nav Bharat etc. (Web-links for news clippings are given in Appendix-II). This has resulted in brand building of AUMP and is likely to result in enhanced admissions in the forthcoming session.
- (b) A strong relationship was built with M.P. High Court, High Court Bar Association, a number of leading lawyers of Gwalior and a number of other institutions that participated in the event.

Justice Brij Kishore Dubey completed his education in the year 1970 from Uttar Pradesh Board of Secondary Education, Allahbad. He then pursued B.Sc. in the year 1972. He then went on to pursue LLB from M.L.B. arts and commerce college and with his steadfast dedication he attained 1st division and got 5th rank in the merit list of Jiwaji University Gwalior. After this he was awarded merit scholarship during the academic session of 1975-76 for LL.M., in the mean time he got selected for the post of Civil Judge class 2. After this he never looked back. He then got promoted as Civil Judge Class-I in 1985 and then as A.C.J.M. in 1989 and as Additional District Judge in 1991. After working as Additional Registrar in Jabalpur High Court and as District and Sessions judge in Sagar he was nominated by the state Govt in consultation with Hon'ble chief justice as member of MP State Legal Services Authority. He was granted selection grade in 1999 and super time scale in 2006. He worked in different capacities at Datia, Rewa, Satna, Mehgaon, Bometara, Morena, Bhind, Neemuch and Jabalpur. Worked as District and Sessions Judge, Jabalpur from 2008 to the date of elevation. He then elevated as Additional Judge of the High Court of MP on 3rd may 2010, sworn in as permanent judge in 2011 and demitted in 2014.

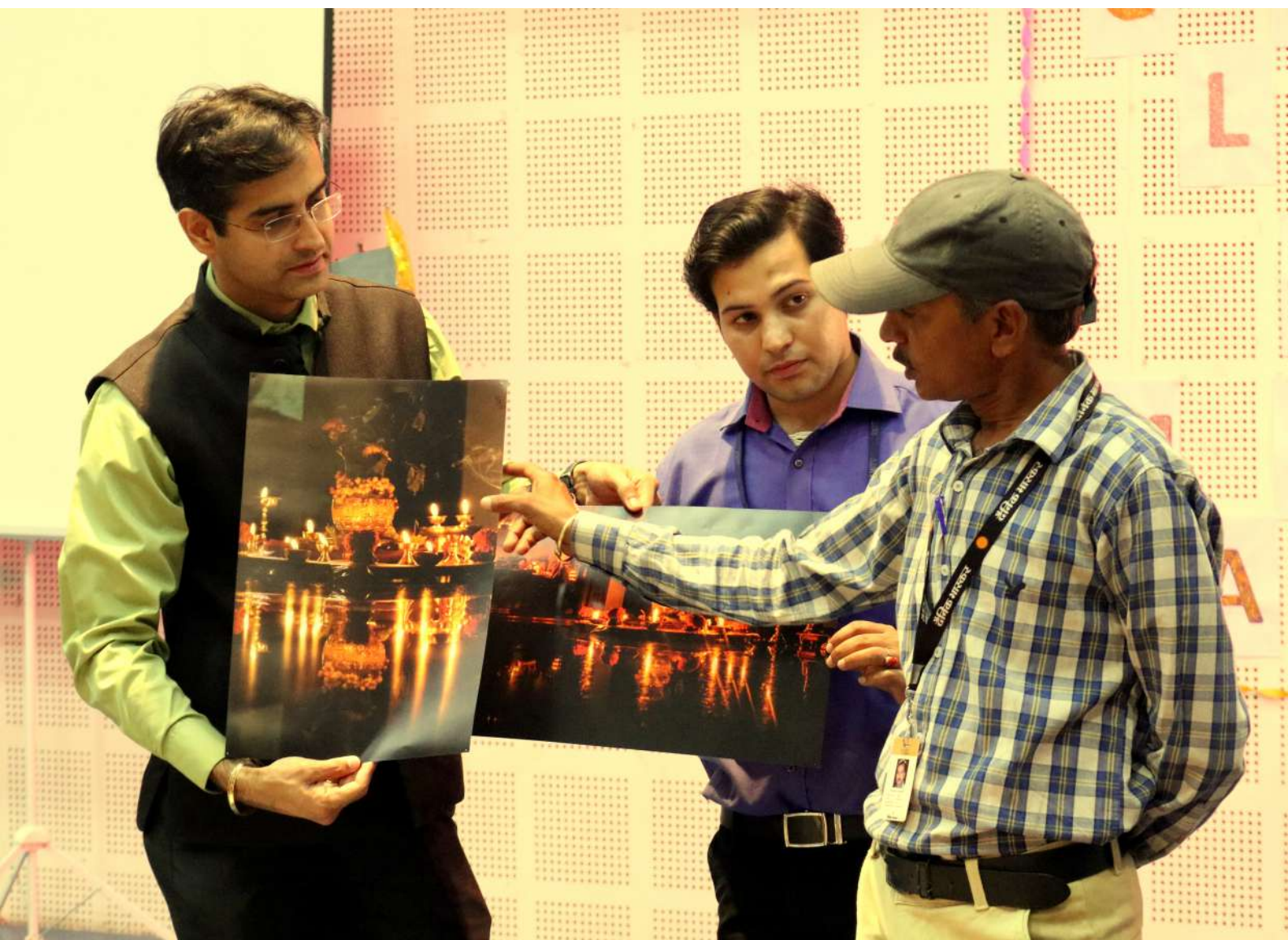
