POLICY FOR PREVENTION OF SEXUAL HARASSMENT OF WOMEN

Introduction

1. In compliance with the mandate of the Hon'ble Supreme Court of India, AUMP proposes to adopt this policy to prevent, prohibit and punish sexual harassment of women at the workplace.

Policy

2. The right of women to protection from sexual harassment and the right to work with dignity are recognised as universal human rights, in accordance with the directive of the Hon'ble Supreme Court, by AUMP Gwalior.

Objectives of the Policy

3. To uphold Women's Right to Protection against Sexual Harassment and the Right to Livelihood and towards that end for the prevention and redressal of Sexual Harassment of Women.
4. To evolve a permanent mechanism for the prevention, prohibition and redress of sexual harassment of women within the jurisdiction of AUMP.
5. To actively promote a social, physical and psychological environment that will raise awareness about and deter acts of sexual harassment of women.
6. To ensure the implementation of the policy in letter and spirit by undertaking all necessary and reasonable steps including the constitution of appropriate Committees for purposes of gender sensitization and to conduct enquiries into complaints of sexual harassment.
7. To uphold the commitment of AUMP to provide an environment free of

Constitution of Committee against Sexual Harassment of Women (CASH)

8. A seven member committee (CASH) has been constituted to prevent, prohibit and punish sexual harassment of women at AUMP .
9. The Committee would have a women as the Chairperson and more than half the members would be women.
10. Both members of faculty and administration would be the members of the said committee. One member, who has the credentials for working for women's causes, would be nominated from outside as an NGO nominee.
11. The said committee would be formed with the approval of the Hon'ble VC AUMP. The names of the Chairperson and the members may be changed for administrative reasons. However, the present composition of the CASH is as follows:-

Definition of Sexual Harassment:

For purposes of this Policy, the following shall constitute sexual harassment of women:-

12. When submission to unwelcome sexually determined behaviour such as sexual advances, requests for sexual favours, and verbal or physical conduct of a sexual nature, are explicitly or implicitly made a term or condition of teaching/guidance, education, employment, participation or evaluation of a woman's engagement in any AUMP activity.

13. When unwelcome sexually determined behaviour, including but not

limited to, sexual advances, physical and /or verbal or non-verbal or conduct, such as loaded comments, remarks or jokes, letters, phone calls, sms or emails, gestures, exhibition of pornography, lurid stares, physical contact, stalking, sounds or display of a derogatory nature have the purpose and /or effect of interfering with a woman's work or academic performance or of creating an intimidating, hostile or offensive employment, educational or living environment.

14. When a man uses with a sexual purpose, the body or any part of it or any object as an extension of the body in relation to a woman without her consent or against her will, such conduct will amount to sexual assault.

Explanation :

(a) It is clarified that it is the reasonable perception of the woman that would be relevant in determining whether any conduct was sexually determined and, if so, whether such conduct was unwelcome or not and that her objection would disadvantage her in connection with her education or employment, including evaluation, grading, recruitment or promotion, or when it creates a hostile working, educational or living environment.

(b) "Hostile Environment" is said to be created when any act of Sexual Harassment has the purpose or effect of interfering with an individual's work performance or creating an intimidating, hostile or offensive employment, educational or living environment.

Procedure

15. The complainant should put up a complaint in writing, addressed to the Chairperson CASH(Committee Against Sexual Harassment) at the earliest possible opportunity, on occurrence of the offence.

16. Such complaints should normally be addressed within 3 working days.

17. The committee will investigate the case and forward their recommendations, findings and action recommended to be initiated against the concerned individual to the Proctor/ Registrar who will put up his recommendation to the Hon'ble VC, AUMP.

18. The decision of the VC, AUMP in all such matters will be final.

Conclusion

19. This policy shall be respected by and will be binding upon all members of AUMP including management, academic staff, non teaching staff, administrative staff, technical staff, support staff, students, consultants, visitors, service providers, holding permanent, temporary, honorary, ad hoc, voluntary or short term positions.


20. Anyone violating this policy will be subject to disciplinary action as detailed in the AUMP Rules and Procedures for the Prevention, Prohibition and Punishment of Sexual Harassment of Women at the Workplace. At AUMP sanctions for sexual harassment may include the full range of disciplinary action up to and including removal from the University.

21. It will be unlawful to retaliate against an employee, student or staff member for filing a complaint of sexual harassment or for cooperating in an enquiry of sexual harassment.

22. The policy will be respected and implemented in letter and spirit.

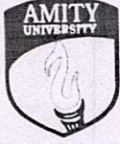

MINUTES : MEETING OF THE BOARD OF MANAGEMENT OF AMITY UNIVERSITY MADHYA PRADESH, GWALIOR HELD ON 23RD SEPTEMBER 2015

1. The Meeting of the Board of Management of Amity University Madhya Pradesh (AUMP), Gwalior was held on 23rd September 2015 at 11.00 AM at the Amity University Campus, Maharajpura, Gwalior (M.P.) under the Chairmanship of Lt Gen V K Sharma, AVSM (Retd), the Vice Chancellor, AUMP, Gwalior.
2. Out of eleven members of BoM, eight members were present in the meeting. The list of Members present in the meeting of the Board of Management is attached as per **Appendix - A**.
3. **Agenda Item No. 1.** **Welcome Address by the Chairman.**

Lt Gen V K Sharma, AVSM (Retd), the Chairman, BoM welcomed all the members of the Board of Management. Vice-Chancellor informed the members that Board of Management is an executive body of the university which takes the decisions passed on the recommendation by the Academic Council of the university as also a few other important decisions.
4. **Agenda Item No. 2.** **Ratification of Minutes of Academic Council meeting held on 04.09.2015**
 - (a) Vice-Chancellor gave the points wise details of the minutes of Academic Council held on 04 September 2015.
 - (b) He briefed the members about the special BoS meeting of ASAP which was conducted to finalize the syllabus of B. Sc. Interior Design since the course tenure of B. Sc. ID has been increased from three years to four years.
 - (c) Prof Y.P. Singh, Director ASAP elaborated the detail about the new syllabus of B. Sc ID to the members.
 - (d) There was discussion about the guest faculties required in ASAP. Prof Y.P. Singh informed the members that as per Council of Architecture 35% of total strength of faculties should be guest faculties. He informed that the guest faculties are mainly required to run the studios of Architecture as they (guest faculties) have the practical knowledge. Prof. Singh also clarified that the strength of students per studio should be 20 only and because of that requirement of guest faculties are more.
 - (e) Dean Academic gave details about the academic calendar for next semester.
 - (f) The minutes of Academic Council meeting held on 04 September 2015 were approved and attached as **Appendix-B**.

- (f) Dr. P.S. Chauhan suggested that Amity University should start NCC.
- (g) Vice-Chancellor informed that Founder President has approved in principal to start the NCC unit at AU MP. He informed that AUMP will first apply for a boys unit.

Panel Discussion on "Glass Ceiling: How Real?"

Date: 9/5/2020

In compliance to the UGC – MHRD’s letter for sensitizing women on Gender Bias and Stereotyping, Gender Equity and Women's Rights in view of ongoing Covid-19 Circumstances, Amity University Madhya Pradesh, Gwalior, organized a Panel Discussion on the topic “Glass Ceiling: How Real?” on Saturday, 05 September 2020.

The Panel Discussion was organized under the aegis of Amity System of Communication Enhancement and Transformation (ASCENT) and Committee against Sexual Harassment (CASH). The panelists of the discussion were Lt. Gen. V.K. 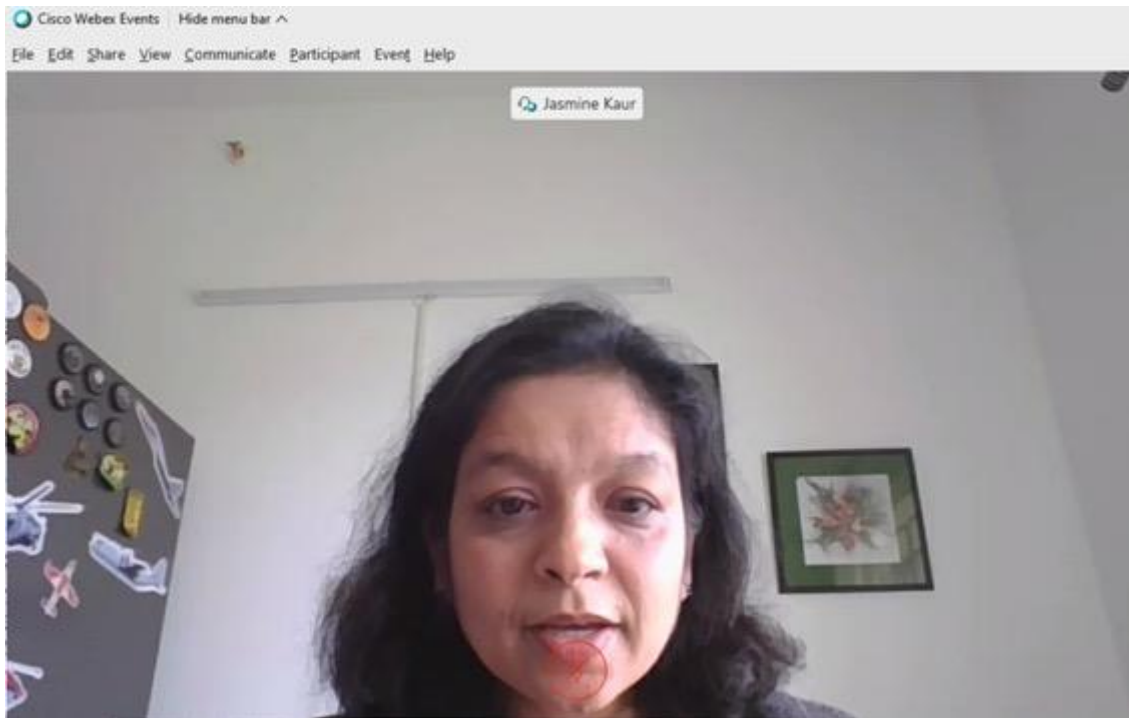

At the end the discussion was concluded with a vote of thanks proposed by the moderator.

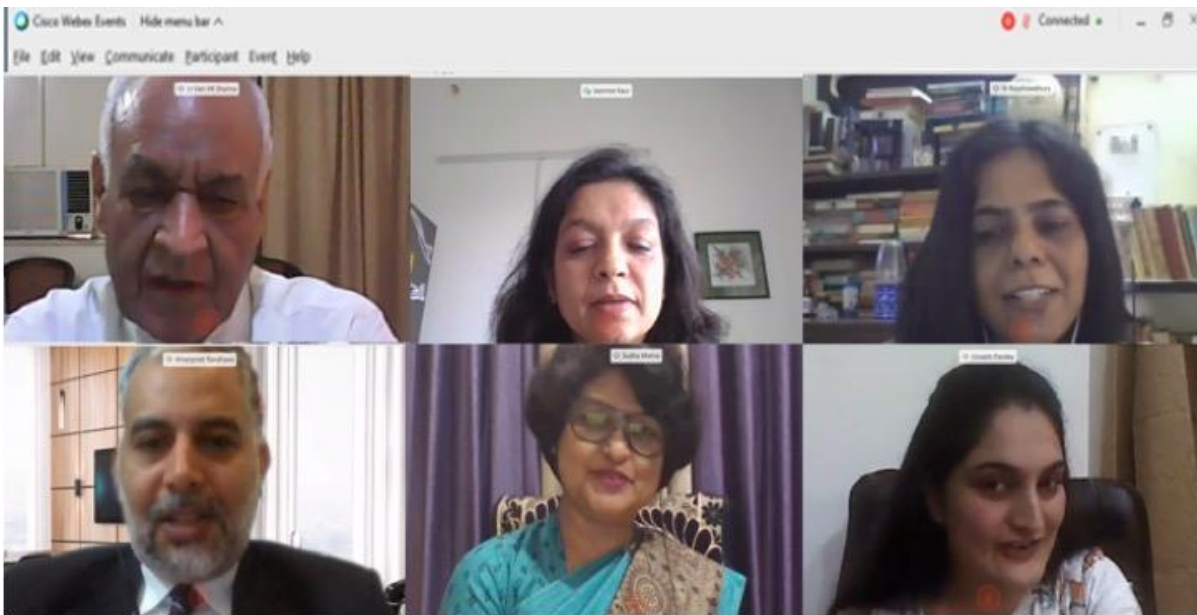
