Mediation Cell was inaugurated virtually in ALS AUMP by Honble Chief Justice of MP Mr Justice Sanjay Yadav.

Madhya Pradesh Legal Services Authority, selected Amity Law School AUMP to open Legal Aid Centres. This is the only Private University in Madhya Pradesh wherein SLSA has approved opening of Legal Aid Centres.

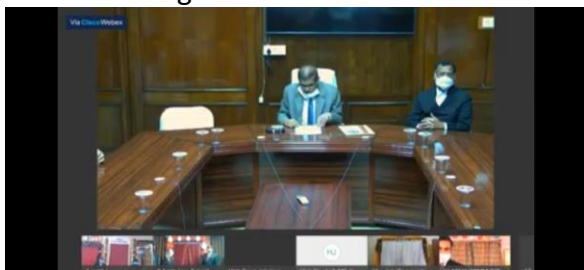
For opening Mediation Centre in an Institution, it is pre-requisite that some faculty must get trained from the SLSA and not through private agency. As stated above, training in Mediation is only imparted to the Judicial Officers/judges by the SLSA. Considering that Prof (Dr) Rakhi Singh Chouhan had earlier undergone 40 hours training in Mediation in NLU Patiala in collaboration with Straus School of Dispute Resolution, Pepperdine University USA, as a special case she was permitted by the Hon'ble Chief Justice of Madhya Pradesh High Court to receive 20 hours training in Mediation. Because of this, we qualified to open Mediation Centre in ALS, AUMP. Prof (Dr) Rakhi Singh Chouhan will also be called in Family Courts and in other matters for mediation pro bono.

It is a matter of pride for ALS that on 17th December 2020 the Hon'ble Chief Justice of Madhya Pradesh High Court has virtually inaugurated Mediation Cell of ALS,AU MP.

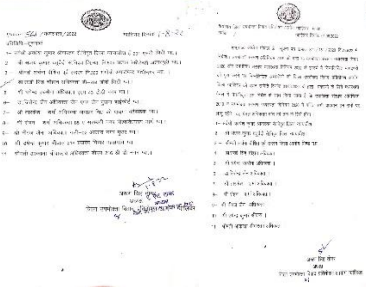

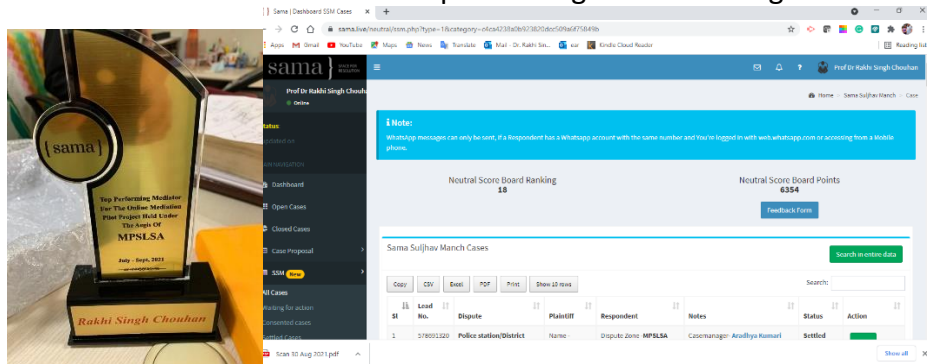

LEGAL AID CAMP IN CENTRAL JAIL GWALIOR

On the occasion of 70th anniversary of drafting of Indian Constitution, the awareness programme on fundamental duties of Indian Constitution are to be organized by District Legal Services Authorities , District Court Gwalior. This programme is as per the order of National Legal Service Authorities and Govt of India. Prof Dr Rakhi Singh Chouhan, HOD and Mr Arun Sharma Assistant Professor ALS are nominated as resource person for the conduct of legal aid camps by DALSA.

On 4th December 2019, legal aid camp was conducted in Central Jail Gwalior. The camp was conducted in two parts in jail- one for under trial prisoners and one for convicted prisoners. Secretary DALSA , Para Legal Volunteers of DALSA and Judicial Officers of District Court Gwalior were present in camp.

Prof (Dr) Rakhi Singh Chouhan delivered lecture to under trial prisoners and Mr Arun delivered lecture to Convicted prisoners. They visited the entire campus and had interaction with all prisoners.

Dr Rakhi found an under trial prisoner who was granted bail from the court but there was no one to furnish the bail. On the initiation of Dr Rakhi the bail was furnished and he was released from jail a day after.

Two cancer patients were admitted in jail hospital whose case was referred to jail authorities for release on humanitarian grounds. On the initiation of Dr Rakhi the appeal of both the patients is filed

LEGAL AID CAMP

FOR AWARENESS TO WEAR MASK AND USE SANITIZER

Amity Law School, AUMP organised a Legal Aid Camp on 28th September in coordination with District Legal Services Authority (DLSA), District Court Gwalior, to create awareness of using masks and sanitizers during COVID 19. It is a statutory requirement to obey the instructions of State or District authorities to wear masks. Hence, the Legal Aid Clinic.

In this Camp, people who were not using masks were explained the importance of using masks. Also, they were explained the importance of washing hands and using sanitizers and the importance of social distancing. On this occasion about 1000 masks and 500 sanitizers were distributed to the poor people who were not having masks.

This camp was organized at Inderganj Chouraha, Gwalior. Inderganj Chouraha of Gwalior is the most active roundabout of Gwalior where vendors, passerby, lawyers, clients, labourers -almost all types of people are found. District Court, Police Station and showrooms are also located at this Chouraha. Therefore, this place was selected for organising the camp. Student volunteers also covered Dal Bazaar, vegetable vendors and passerby who were not using masks and distributed masks to them. The students actively identified the people who were not using masks or using cotton cloth to cover their faces. They were sensitized to use the masks regularly. The social distancing was well followed in camp by organisers and participants.

The sanitizers were sponsored by the student of ALS Ms Aishwarya Shandilya BBALLB 5th Sem. Ms Aishwarya Shandilya established the Unit to manufacture sanitizers and soaps during lockdown period. She employed the women workers in this work, who lost their jobs due to lockdown and promoting the notion of 'Atmanirbhar Bharat'.

On the auspicious occasion of birthday of our Hon'ble Chancellor, it was a great pleasure distributing masks and sanitizers to the needy people and creating awareness during the period of Pandemic.
