- (iv) To introduce Fast Track Course for LL.B Xth Sem. students from 2013-2018 batch onwards. The X Sem. Course is proposed to end somewhere in mid-March of each year. This will facilitate students of LL.B Xth Sem, to have longer duration of internship of 3-4 months. This will improve their job/placement prospect.
- (v) To map and realign various papers of LL.B programme with a view to accommodate Fast Track Course for LL.B Xth Sem.
