



## Minutes of B.O.S Meeting

1. A Meeting of Members of BOS of ALS was held on 29 Aug. 2018.( Meeting Notice attached at Annexure-1)
2. The agenda of Meeting was to discuss the Course Curriculum/ Syllabus of Course " Corporate Taxation" ILB/BCL/BBL, 902 CG (2014-2019). The need for change of course curriculum/syllabus was felt due change of Tax Regime after recent introduction of GST by Govt. of India.
3. In the meeting it was unanimously decided to change the Course Curriculum/Syllabus of Corporate Taxation in view of introduction of GST by Govt. and the old Tax structure e.g. Sale Tax. Wealth Tax considered of not much relevance. The Course Curriculum of Mangalore & Mysore University was also taken into consideration. The proposed Course Syllabus is on the lines of these two Universities which has also been recommended by Professor Dr. Vijay Kapoor, President Raffles University.

Accordingly BOS has recommended for modification of the existing Course Curriculum/ Syllabus of Corporate Taxation. The existing & proposed syllabus are attached at Annexure 2 & 3.


4. The Proposed & approved Course Curriculum/Syllabus is being introduced from current batch 2014-2019.
5. Approval of President AUR and Academic Council AUR will be sought.
