1. The Chairman welcomed all the members and expressed gratitude to the member for having spared their valuable time for the benefit of the University and expressed hope that there would be meaningful deliberation on the agenda points.

### **2. Minutes of the meeting are as under:-**

2.1 In pursuance of deciding and approving upon the said syllabus for B.A./B.COM./B.B.A. LLB (UG) programme for Batch 2019-24, it was proposed and agreed between the members that as per BCI Rules of Legal Education 2008 (Part –IV- Schedule II) 5yrs Integrated Prog. (With Specialization) must be taught *not less than* 53 subjects spread across 10 Semesters at the Law School which shall include the following genres of paper:

- 12 Management subject papers;
- 02 Compulsory English subject papers;
- Not less than 38 Core Law Papers including 20 Compulsory Law Papers, 4 Clinical papers, 6 Optional papers, 8 Honors Subject papers;
- Expected to learn at least one Foreign or Indian Language.
- One paper of Environmental Studies & Disaster Management

2.2 The members have unanimously agreed that the not less than 52 papers spread across 10 semesters must be taught. After considering the best practices of Amity University Rajasthan and referring the proposed **Course Grid of 2019-24 (Annex. 1a)**, BOS members agreed that students must be taught : **26 Core Law papers + 12 management +2 English paper + 4 Clinical papers+ 01 paper on Basics of Computer Applications+ 02 papers of Fundamentals of Moot Court+ 01 paper of Environmental Studies & Disaster**

**Management+ 06 papers of Behavioural science + 02 papers of Communication Skills+ 06 papers of Foreign language+ 08 Honours papers + 6 Optional papers**, with an average of 7-8 papers/ semester. The BCI Rule of Legal Education 2008 (Chapter II Para 10) states that there shall be not less than **36 class hrs / week** including seminar, moot court & tutorial classes and **minimum 30 lecture hours/week**. Thus it must be ensured that BCI mandatory papers are be allocated a total of 5 lecture hours / week. Thus total teaching hours in a week must be 30+6=36 hrs. , which will fulfills BCI mandate. (36 hrs/ week\* 18 weeks=648 hrs /semester)

### 2.3 The members agreed to following changes in Batch 2019-24: (Annex. 01b)

- 1) To remove all Domain Electives which include 2 compulsory domain 8x2credits=16 credits. **Reasons:-**
  - a. All listed domain electives across law schools in India are taught as a part of main core papers, each Core paper/Elective paper and Domain elective in ALS as of now are 3+3= 6 Credits for each paper; which are running as one main core paper with 4 credits in all Law Schools.
  - b. Each paper of 3 credits which is not worthy of content of syllabus of Domain Elective.
  - c. Hence suggested to merge Domain electives into Core papers as following :
    - i. To merge Sale of Goods & Hire and purchase LLB104 with Contract II LLB 202 in module III.
    - ii. To merge Motor Vehicle Act, 1988 LLB 203 with Law of Torts LLB 201 as new Module IV.
    - iii. To merge SC & ST Act 1989 LLB305 & The Protection of Women from Domestic Violence Act 2005 LLB406 & The Suppression Of Immoral Traffic In Women And Girls Act, 1956. with Socio Economic Offences LLB 1005 CRL (Optional Paper)
    - iv. Registration Act 1908 LLB506 is already part of Property law LLB 504 as module VI
    - v. To merge The Juvenile Justice (Care And Protection Of Children) Act, 2015 LLB607 with Law of Crimes II LLB401 as a new module.
    - vi. Legal Services Authorities Act,1987 LLB 708 to be part of Professional Ethics & Professional Accounting system LLB1002.
    - vii. The National Green Tribunal Act 2010 LLB 807 to be part of Environmental Law LLB1003 which is incorporated as module IV.
    - viii. All clinical papers Judgment Review LLB306, Family Law LLB407, Property Law LLB507, Criminal Law LLB606, Property Law LLB 709, Drafting of Writs LLB 808, Labour Law LLB909 may be introduced as last module in respective Core paper Or alternately in Clinical Paper- Drafting, Pleading & Conveyancing LLB902.
    - ix. Competition Law LLB1007 is already compulsory Honors paper of Corporate Law specialization.
    - x. Goods and Service Tax Act, 2017 LLB1008 is already included in module IV of Law of Taxation LLB901

- 2) With reference to point 1(c)(iii) convert Socio -Economic Offences paper from Criminal Honors to General Optional paper and Introduce 'Comparative Criminal Law' as Honors papers for Criminal law group.
- 3) To meet up requirement of BCI Rules of Legal Education, 2008 Schedule II Para 4(b) introduce 6 Optional papers with already existing 08 Honours papers & 12 Core Management/ Arts/Commerce papers and 20 Compulsory Core-law papers. (06 additional Compulsory Core-law papers) and 04 Clinical papers.
- 4) In reference to point 3: Out of 12 Core of Management/ Arts/Commerce papers 02 shall be of 03 credits instead of 4 credits as the semester teaching of these papers already concluded: The papers are: Management foundation / Economics -I/ Financial accounting -1 ; Micro economics for business/ History I/ Microeconomic Theory & Application-1
- 5) Increase as per BCI Rules & Regulation Schedule III credits from 3 credits to 4 credits of courses listed in point (3) above, (06 additional Compulsory Core-law papers may be of 3 credits)
- 6) Reduce Behavioral science papers from 09 to 06 with 01 credit each hence total =4 papers\*1 credit=06 credits
- 7) Reduce Communication papers from 06 to 02 with 01 credit each hence total =2 papers\*1 credit=02 credits
- 8) Reduce Foreign language paper from 09 to 06 with 01 credit each hence total =4papers\*1 credit=06 credits
- 9) Reduce Moot Court Exercises and Internship- Clinical papers (LLB1001) from 16 credits to 4 credit
- 10) Remove all non-credit 07 Moot Papers and replace with Fundamentals of Moot Court- I & II with 1 credit each , hence two papers 2\*1each= 2 credits
- 11) In reference to point 10 to assess both Fundamentals of Moot Court- I & II with continuous assessment and there shall be no End term examination.
- 12) Introduce a paper titled General English paper which is mandatory by BCI schedule III with 03 credits.
- 13) Introduce a paper titled Basics of Computer Applications with 02 credits.
- 14) Shift paper titled Intellectual Property Rights and Interpretation of Statutes from optional papers to Core papers with 04 credits each.
- 15) Optional papers have no alternative choices for students hence optional paper choices may be introduced as following:

1. Banking and insurance Laws OR Election Law
2. International Trade Law OR Animal Protection Law
3. Cyber Law OR Sports Law
4. Local Self Govt in India OR Air and Space Laws
5. Land Law including tenure and tenancy system OR Private international law

- 16) Rename Labour Law- I & II as Labour and Industrial Law- I & II
- 17) Rename paper titled 'Environmental Studies' (EVS002) as 'Environmental Studies & Disaster Management' as mandated by UGC on SC decision and introduce a module on Disaster Management.
- 18) Rename Law of Torts (Consumer Protection Act ) (LLB201) as Law of Tort (including Accidental Claims) and Consumer Protection Act
- 19) Rename paper Property Law as 'Law Transfer of Property, Easement, Trust & Equity' and include a module on Trust & Equity.

20) Total Credit previous course structure =260 credits. Approved prog. Structure = 258 credits.

3. Members agreed that necessary changes must be made in course grid of Batch 2018-23 & 2017-22 to get at par with course structure mentioned in para 2.3:

3.1 The members agreed to following changes in Batch 2018-23: (Annex. 2a)

1) To remove all Domain Electives from Semester III onwards which include 2 compulsory domain  $6 \times 2 \text{credits} = 12 \text{credits}$ . Reasons:-

a. All listed domain electives across law schools in India are taught as a part of main core papers, each Core paper/Elective paper and Domain elective in ALS as of now are  $3+3=6$  Credits for each paper; which are running as one main core paper with 4 credits in all Law Schools.

b. Each paper of 3 credits which is not worthy of content of syllabus of Domain Elective.

c. Hence suggested to merge Domain electives into Core papers as following :

i. To merge SC & ST Act 1989 LLB305 & The Protection of Women from Domestic Violence Act 2005 LLB406 & The Suppression Of Immoral Traffic In Women And Girls Act, 1956. with Socio Economic Offences LLB 1005 CRL (Optional Paper)

ii. Registration Act 1908 LLB506 is already part of Property law LLB 504 as module VI

iii. To merge The Juvenile Justice (Care And Protection Of Children) Act, 2015 LLB607 with Law of Crimes II LLB401 as a new module.

iv. Legal Services Authorities Act,1987 LLB 708 to be part of Professional Ethics & Professional Accounting system LLB1002.

v. The National Green Tribunal Act 2010 LLB 807 to be part of Environmental Law LLB1003 which is incorporated as module IV.

vi. All clinical papers Judgment Review LLB306, Family Law LLB407, Property Law LLB507, Criminal Law LLB606, Property Law LLB 709, Drafting of Writs LLB 808, Labour Law LLB909 may be introduced as last module in respective Core paper Or alternately in Clinical Paper- Drafting, Pleading & Conveyancing LLB902.

vii. Competition Law LLB1007 is already compulsory Honors paper of Corporate Law specialization.

viii. Goods and Service Tax Act, 2017 LLB1008 is already included in module IV of Law of Taxation LLB901

- 2) With reference to point 1(c)(i) convert Socio –Economic Offences paper from Criminal Honors to General Optional paper and introduce 'Comparative Criminal Procedure' as Honors papers for Criminal law group.
- 3) To meet up requirement of BCI Rules of Legal Education, 2008 Schedule II Para 4(b) introduce 6 Optional papers with already existing 08 Honours papers & 12 Core Management/ Arts/Commerce papers and 20 Compulsory Core-law papers. (06 additional Compulsory Core-law papers) and 04 Clinical papers.
- 4) In reference to point 3: Out of 12 Core of Management/ Arts/Commerce papers ; 06 papers shall be of 03 credits instead of 4 credits as the semester teaching of these papers already concluded in previous semesters i.e (Semester 1-3): The papers are: Management foundation / Economics -I/ Financial accounting -I ; Micro economics for business/ History I/ Microeconomic Theory & Application-I; Macroeconomics for business/ Economics -II/ Financial accounting –II; Organizational behaviour/ History II/ Microeconomic Theory & Application-II; Marketing management- I/ History III/ Cost & Management Accounting-I
- 5) Increase as per BCI Rules & Regulation Schedule III credits from 3 credits to 4 credits of courses listed in point (3) above, (06 additional Compulsory Core-law papers may be of 3 credits)
- 6) Reduce Behavioral science papers from 09 to 06 with 01 credit each hence total =4 papers\*1 credit=06 credits
- 7) Reduce Communication papers from 06 to 02 with 01 credit each hence total =2 papers\*1 credit=02 credits
- 8) Reduce Foreign language paper from 09 to 06. Foreign language paper 1& 2 studied in previous semesters ( i.e. Semester 1&2) hence remain for 2 credits and subsequent semesters 4 four papers shall be 1 credit each . Thus total Foreign lang 6 papers credits shall be 08.
- 9) Reduce Moot Court Exercises and Internship- Clinical papers (LLB1001) from 16 credits to 4 credit
- 10) Remove all non-credit 07 Moot Papers and replace with Fundamentals of Moot Court- I & II with 1 credit each , hence two papers 2\*1each= 2 credits
- 11) In reference to point 10 to assess both Fundamentals of Moot Court- I & II with continuous assessment and there shall be no End term examination.
- 12) Introduce a paper titled General English paper which is mandatory by BCI schedule III with 03 credits.
- 13) Shift paper titled Intellectual Property Rights and Interpretation of Statutes from optional papers to Core papers with 04 credits each.
- 14) Optional papers have no alternative choices for students hence optional paper choices may be introduced as following:

3.2 The members agreed to following changes in Batch 2017-22: (Annex. 2b)

The students are presently in Semester V hence proposed changes shall be effective only for prospective semesters:

- 1) Paper LLB 906 CRL Socio-Economic offence replaced by Comparative Criminal Procedure and this paper realigned in Optional Paper.
- 2) To meet up requirement of BCI Rules of Legal Education, 2008 Schedule II Para 4(b) introduce 6 Optional papers with already existing 08 Honours papers & 12 Core Management/ Arts/Commerce papers and 20 Compulsory Core-law papers. (07 additional Compulsory Core-law papers) and 04 Clinical papers.
- 3) In reference to point 2: All 12 Core of Management/ Arts/Commerce papers shall be of 03 credits
- 4) Increase as per BCI Rules & Regulation Schedule III credits from 3 credits to 4 credits of courses attached in annex 2(b)
- 5) Reduce Behavioral science papers from 09 to 06 with 01 credit each hence total =6 papers\*1 credit=06 credits
- 6) Communication Skills removed from V Semester onwards and restructured as two (2) Papers only studied in Semester III and IV only.
- 7) Reduce Foreign language paper from 09 to 06. Foreign language paper 1-4 studied in previous semesters (i.e. Semester 1-4) hence remain for 2 credits and subsequent semesters 2 papers shall be of 1 credit each. Thus total Foreign lang. 6 papers credits shall be 10.
- 8) Reduce Moot Court Exercises and Internship- Clinical papers (LLB1001) from 16 credits to 4 credit
- 9) Remove all non-credit 07 Moot Papers and replace with Moot Court- I & II (already studied these papers in Semester III & IV) with 1 credit each, hence two papers 2\*1each= 2 credits. Since these were non-credit courses, marks for both papers to be included in student IX semester mark sheet with 1+1= 2 credits
- 10) Optional papers have not been introduced hence optional paper choices may be introduced as following:

1. Banking and insurance Laws OR Election Law
2. International Trade Law OR Animal Protection Law
3. Cyber Law OR Sports Law
4. Local Self Govt in India OR Air and Space Laws

- 14) Total Credit previous course structure =285, Approved prog. Structure = 266 credits.

#### 4. The changes in Academic Calendar of U.G. batches:

4.1. To meet the BCI teaching hrs. mandate and to give sufficient time to students to undertake Internship the member agreed to that following Academic Calendar may be opted for upcoming Even semester 2019 for batches 2019, 2018, 2017, 2016 as following:

- a) February 03, 2020 –June 30,2020 (20 weeks with 90 days teaching followed by 6 weeks of vacation & internship) (Annex. 3a)

Members recommended to ensure that student has undertaken internship 'COURT/INTERNSHIP DIARY' must be mandate

4.2 Members disagreed for *Fast Track Course* for final year U.G. courses batch 2015-20 as it violates the 90 days mandatory teaching of UGC & BCI Notification dated 11/09/2014 which states that 'students can only take internship during the vacation'. (Annex. 3b)

Hence members agreed that Amity Law School may either follow same calendar as mentioned in 4.1 for batch 2015-20 also or alternately may follow the previous approved academic calendar i.e Dec 16, 2019 – May 15, 2020.

5. The members approved the syllabus of newly introduced / revised papers: (Annex 4)

- a) Banking & Insurance laws
- b) Fundamental of Moot court- I & II
- c) Basics of Computer Applications
- d) Election Laws
- e) Behavioural Science – Paper I –VI
- f) Communication Skills – I & II

6. The members agreed that above approved changes may be incorporated with immediate effect from current semester itself as ALS has conducted Batch 2019-24 & 2018-23 & 2017-22 classes with revised proposed credits except for management/arts/commerce papers of respective batches.

7. The members agreed that the REMEDIAL CLASSES must be conducted before End Term Examination for the students (both UG & PG courses) before declaration of Debarred list.

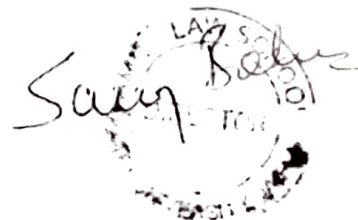
