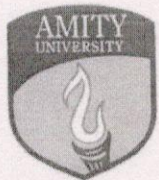

Procedure to lodge a complaint :

The victim or a third party may lodge a written complaint addressed to the Convenor of the Committee. If the complaint is made to any of the Committee members, they shall forward the same to the Convener of the Gender Cell for further action.

The Committee shall submit its report to the office of Registrar within 15 days of the complaint for further review and approval of the Vice Chancellor.

The 'Guidelines for Internal Complaint Committee' promulgated vide 'Gazette of India' dated 02/05/2016 and POSH Act 2013 is attached for reference and compliance.
