Online Application Process for Scholarships (AY 2026-27)

All students are hereby informed that the application for the following scholarships shall be processed in online mode through the Amizone portal for the Academic Year 2026-27, in order to streamline the process and ensure greater efficiency and transparency:

1. Continuation of On-Admission Merit Scholarship
2. Merit Scholarship – During a Programme
3. Merit-Cum-Means Scholarship

Eligible students are required to apply online for the above scholarships through their respective Amizone accounts only. Students must ensure that they have completed their registration for the next semester (AY 2026-27) before proceeding with the scholarship application.

The online application link will be activated by 13th July 2026 and will remain open till 31st July 2026.

Students are advised to submit their applications well within the stipulated timeline, failing which their application will not be considered for the award of scholarship for the Academic Year 2026-27.

A copy of the Scholarship SOP and Guidelines is attached herewith for ready reference.

SOP - Scholarships

On-Admission Merit Scholarship:

- Initiated by Admission Dept. at the time of admission of a candidate, on the basis of qualifying examinations & percentage.

Continuation On-Admission Scholarship

(THROUGH ONLINE PROCESS)

- The results shall be uploaded by the examination department, through the Amizone account of CoE.
 - Activation of scholarship form by Registrar's office.
- Students performance will be based on achieving minimum 8.5 CGPA and student must be in the top 15% of the batch.
- Individual eligible student shall apply for the scholarship through their respective Amizone account only.

Merit Scholarship - During a Programme

(THROUGH ONLINE PROCESS)

- Activation of scholarship form by Registrar's office.
 - Batch size of the programme should be above 30.
- Individual eligible student shall apply for the scholarship through their respective Amizone account only.
- The scholarship shall be renewed each year thereafter on the basis of academic performance of the students.

Merit-Cum-Means Scholarship

(THROUGH ONLINE PROCESS)

- Activation of scholarship form by Registrar's office.
- Family income from all sources should not exceed Rs. 3,00,000/- per annum.
- Individual eligible student shall apply for the scholarship through their respective Amizone account only.
- The required documents will be uploaded online by the student, as per the checklist.

Scholarship for Ex-Amity Students:

- Student should be passed out from any of the Amity University Rajasthan.
- Initiated by Admission Dept. at the time of admission on submission of the required documents.

Guidelines - Scholarships

- I. On-Admission Merit Scholarship:** The scholarship will be granted as per the conditions through Admission Notification every year to the meritorious candidates after passing 10+2, Graduation or such other qualifying examinations prescribed by the University. The amount of scholarship will be 100%, 50% or 25% of tuition fee based on percentage of marks in qualifying examinations.

[This scholarship will be processed by the Admissions and Marketing Department at the time of student's admission.]

- II. Continuation On-Admission Scholarship (THROUGH ONLINE PROCESS):** On the basis of performance of student in the last academic year and securing a minimum CGPA of 8.5, student may be eligible for award of continuation on-admission scholarship.

But, if the batch Size is less than 20 in any programme, then only Rank 1, 2, 3 shall be eligible for scholarship subject to following conditions:

[Eligible students shall apply for the scholarship online only through their respective Amizone accounts]

- III. Merit Scholarship - During a Programme:** The scholarships will be awarded at the end of first year on the declaration of the first-year results and renewed each year thereafter on the basis of academic performance at the end of each academic year. The following criteria must be fulfilled:

- Student should be in the top 10% of their program batch.
- Student should pass all examinations in the first attempt as per the normal examination schedule.
- The amount will be equal to 30% of the tuition fee for the subsequent year, rounded to next multiple of Rs.100/-.
- Student should remain in top 10% of the merit list, for continuation of the scholarship.

- The number of Merit Scholarships will be as under:

1	1-30	NIL (Only Merit Certificate)
2	31-90	One
3	91-180	Two
4	Exceeding 180	Three

[Eligible students shall apply for the scholarship online only through their respective Amizone accounts]

III. Merit-Cum-Means Scholarship: The scholarships will be granted from the first year of a programme and will be reviewed each year thereafter.

- The family income from all sources should not exceed Rs. 3,00,000 per annum.
- The scholarships decided based on merit for the first year and CGPA for subsequent years.
- Application required on prescribed format with supporting documents.
- Not admissible if receiving other scholarships/grants that exceed the total income limit.

[Eligible students shall apply for the scholarship online only through their respective Amizone accounts]

IV. Scholarship for Ex-Amity Students: The scholarships will be granted to the students who have passed out from Amity University Rajasthan.

- 25% fee exemption in tuition fee in first year.
- Not applicable if there is a gap of one year or more between passing the qualifying exam and seeking admission.

[This Scholarship will be processed by the Admissions & Marketing Department at the time of admission of the student from UG to PG.]

General Conditions for withdrawal: Scholarship may be withdrawn if.....

- Student adopts unfair means in examinations or is debarred.
- Report of misconduct, misbehavior, gross indiscipline, ragging, drug/narcotic use, etc., is established.
