The Executive Committee, after consideration of the same, has decided to grant extension of approval to **5-year full-time Bachelor of Architecture (B.Arch.) degree course** as under:

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture and maintenance of physical infrastructure & facilities at your institution in terms of Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020, prior to commencement of academic session 2026-2027. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

It may further be noted that the Council has appointed an Inspection Committee which shall visit the Institution in due course (during the session 2026-2027) to verify compliance with the prescribed norms and to ascertain that the architectural course is being imparted in accordance with the standards prescribed by the Council. The details regarding the inspection shall be communicated separately by the Council.

In the event of any deficiency being noticed in the conduct of the architectural programme or non-compliance with the prescribed norms of the Council, appropriate action, including reduction in intake and/or withdrawal of approval, may be initiated against the Institution.
