The members of the Board of Management applauded the efforts made by Amity University Maharashtra on the research front.

Agenda - 9

Proposal for provision of seed money for research to deserving young faculty and incentives for publication in high impact journals.

The Deputy Registrar invited the Honble Vice Chancellor to inform the members of the Board of Management regarding a proposal for the provision of seed money for research to deserving young faculty and incentives for publication in high impact journals.

With regard to this agenda, the hon'ble Vice Chancellor was delivering an update on the proposal for provision of seed money for research to deserving young faculty and incentives for publication in high-impact journals, and it has been submitted to the hon'ble Chancellor.

He further added two things in this regard: i) we are proposing seed money of around Rs. 20,000 to Rs. 50,000 per deserving faculty member for research in order to create primary data for the submission of funded projects. ii) We proposed incentives for the publication of high-impact papers. We have submitted these two proposals to the hon'ble Chancellor for further approval and deliberations.

Dr. K. K. Dwivedi has two observations in this regard, i) seed money is one of the important parameter metrics for NAAC accreditation and NIRF ranking, but NAAC benchmarking is at a minimum of one lac per teacher, so seed money will not get any marks in this regard. The mechanism that has to be implanted by the campus, where the money is spent on buying the mechanism that has to be implanted by the campus, where the money is spent on buying equipment, chemicals, supplies, and other kinds of consumables, should also be divided into the teachers' accounts. Whoever joined is likely to get seed money, and the laptop given to them should have mentioned that it is a part of seed money. The concept of seed money is that every teacher should write a mini-research project that has a title line and certain objectives, and the university gives them funds. The funds are to be utilised by the teachers, and a utilisation certificate is to be posted in the university's annual

account (balance Sheet). That amount was spent on X numbers of teachers; all teachers get some Rs. 50,000, Rs. 40,000, and Rs. 20,000, and collectively, the university spent 10 lacs of rupees over the period of five years. ii) Another point is an incentive for research publications. Different disciplines have journals with different scales of impact factors, e.g., in medical and biological sciences, the journals have a higher impact factor compared to physics. There has to be a scaling of the impact factor subject wise in place.

Specific comments from the members were invited by the Hon'ble Vice Chancellor Sir,

Clarifying the points raised by Prof. Dwivedi, the Hon'ble Vice Chancellor said that i) about the seed money, NAAC needs a separate letter with the direct placement of Rs. 1,00,000/-, e.g., the laptop and any support system are going to give faculties that is not being counted as seed money. ii) With regards to the publications, we are planning to have slabs of the impact factor, like 4-5, 5-6, 6-7, and above 7.

Prof. (Dr.) Amit Jain at the onset applauded the efforts in regard to the seed money clarifications by the Hon'ble Vice Chancellor, and he added that NAAC is very clear that they want a sanction letter with the topic and title of the project. Somehow, these instruments, consumables, or laptops don't work, so it is better to have a very clear-cut seed grant policy of the university in place and incentives to be paid to the faculties, as Dr. Dwivedi stated earlier. He further added that the seed grant may also work for the retention of the faculties.

Mr Ashis Bindra suggested in this regard for seed money grant that, one part of the salary component of the faculties can be a seed money. He further added, we can give upfront the seed money to the faculties rather it is on periodicals; therefore, the young faculties may be encouraged.

Dr. Gulshan Wadhva emphasizes the suggestion given by Dr. Dwivedi regarding seed grant money. He added that innovation and technology should be part of this; it should be project-oriented towards innovation and technology, specifically at least 50% of the total. He applauded and congratulated the members of the board of management for the achievements of the university. Further, he added that the
