### MEMORANDUM OF UNDERSTANDING

- To advance the clinical training and practice of M.Phil/MA Clinical Psychology Students.
- To further public education therein; and
- To promote research work in Mental Health, understanding and treatment of mental health disorders in all its forms and aspects and related subjects and publish the results of all such study and research,

Whereas **Jagruti Rehabilitation Centre, Talaja** requested advice and cooperation in achieving the following main objectives.

- Capacity building in primary care to deliver quality mental health.
- Provide quality secondary care and advice to primary care
- Use principles of Clinical Psychology as appropriate
- Enhance public education on mental health to combat stigma against mental health
- Collaborations to enhance mental wellbeing
- Participate in developing training in mental health at individual and community level.
- Mental Health training to providers of education and social work.

Whereas Department of Clinical Psychology, AIBAS, AUM and Rehabilitation Centre, Talaja wish to cooperate in their respective fields of mutual interest;

Now therefore, the parties here to agree to sign a general framework agreement on collaboration, subject to specific annexes, which will permit the exchange of Clinical training experience and the organization of joint activities, in close collaboration, pursuant to the following objectives:

1. To establish close collaboration in all relevant fields through the AIBAS, AUM, Panvel.
2. To enable the exchange of relevant academic information between both institutions in areas relating to Clinical Psychology training and teaching activities.
3. To promote joint research projects in areas relevant to Clinical Psychology.
4. To study the viability of establishing assistance to professionals and students who wish to undertake periods of training in either of the object of this agreement.




5. Exchanging trainees through the volunteer scheme.
6. Collaborating and exchanging expertise in initiatives to balance patients' and carers' rights for care and treatment.
7. To share experience in raising understanding of advocacy about mental health with our respective management.
8. Translations of relevant fact sheets and information regarding patient related educational materials and pamphlets into local languages will be carried out with due acknowledgement and referral as and when required for the practical training of M.Phil/MA Clinical Psychology Students.

**Term**

This agreement remains valid for a term of 5 years subject to periodic reviews. The agreement may be terminated by either party at any time before the end of the term, subject to three months' prior written notice.
