Legal Aid Camp & Environment Day

On the occasion of World Environment Day, Amity Law School and Amity Institute of Liberal Arts had jointly organized Legal Aid Camp and celebrated World Environment Day at Phansad Wild Life Sanctuary in Tal. Murud, Dist. Raigad. It was Interdisciplinary activity that aimed to understand tribal life. Phansad Wild Life Sanctuary is located in Raigad District and spread across 52 Kilometer. There are leopards, wild bore, birds, deer, and butterflies.



Sumradevi Tribal Hamlet is near Phansad, and 35 tribal families reside there. These families are Katkari Tribes which are Primitive Tribes, and the majority of them are settled in Raigad District. These families depend on daily wage activities for their livelihood. Therefore, there is a major issue of accessibility of Education and Healthcare Facilities. There are no toilets in this area; hence, personal hygiene and health are the major issues.

Gender discrimination was observed as the disparity in payment to men and women. Men are paid higher than women for equal work

ABOUT THIS COURSE

This course is a part of UNESCO's Open Education for a Better World Project. It is completely FREE of cost and online. The course is a type of small training for all the participants which will require a minimum involvement of 15 to 20 hours of investment in total. Main objective of the course is to provide right knowledge of suicide (sensitization), required skills in identification, screening and assisting at risk youth (assessment and counseling skills) and promotion of suicide prevention (campaigning and sensitization in higher educational campuses and other

"Youth is the most creative and energitic phase of an individual life which presents a phase full of liberation with new introduced responsibilities. The chances of first appearance of many mental health issues are more in this phase than any other stage due to various factors. interaction of these mental health issues with external factors like academic related stress, relationship, peer pressure, competitions etc. become a significant cause of serious problems like suicide, increasing rate of suicide at this age is now a big concern for everyone and it has become a social problem. Youthsuicide not only creates extreme distress in one's family but it can be debilitating to national progress. Recent researches claims that early identification and screening of suicidal ideations and tendencies can prevent suicide amona youth. This process requires both sensitization of the significant people of the society and to provide them necessary skills of identification, screening, referring and monitoring. At higher educationa institutes educators, counselors, student council members, wardens, mentors, hostel staff, physicians and parents can be instrumental in this process since these people are directly connected to young adults. As far as Indian educational system is concerned, such programs in India, are at nascent store. Here numerous initiatives are being taken up by government to take care of mental health issues of students, however specific programs like screening and prevention of suicide are still uncommon. I personally feel that there can be two reasons for the same. One of the reason is the higher cost of implementation of such program through mental health professionals and another could be non-availability of enough mental health professionals in country. However, these reasons cannot reduce the importance and necessity of such programs in the present scenario. Therefore, open education can be one of the cost effective way to implement such program without much involvement of infrastructure and human resource at the same time not compromising with authenticity and quality of the program. My motivation behind developing this program is to reach to maximum people through this platform of open education and to pave way for implementation of such important program in India where youth comprise of more than half of the population of the nation. I would like to work for this cause as a mental health professional."

DETAILS OF THE COURSE

This course focuses on disseminating genuine information regarding suicide, debunking myths related to suicide, improving protective factors at various levels, developing competence in participants for suicide prevention, suicide prevention screening strategies in that could be employed by educational campuses.

During the session, Mr. Girish law school student gave some insight on the sexual assault cases and how the cases can be reduced by giving the right knowledge to society.





A Legal Awareness Programme

A Legal Awareness Programme was organized by the students of Amity Law School in the series of Pan India Awareness and flagging the motto of Justice For All.

Paralegal Volunteers Ms. Riddhi Munoth, Mr. Girish Ambapkar, Ms. Priya Nair, and Mr. Pulkit Awasthi distributed flyers in 9 villages and conducted a session on the Schemes of Legal Aid Services and how each one is entitled to free and true legal aid services. The focus of this session was to share the knowledge about poverty, sexual assault, and exploitation, disaster

management, etc, and share the core principles and anthem of NALSA and the thought of Free legal services. The idea behind sharing the flyers with the villagers was Each One - Teach One. The Paralegal Volunteers explained this small task to each villager that if one person of the village is explaining these concepts and schemes to a minimum 1 person of the village. And the same chain continues with the intention that there will be no village in this country that would not know about the services provided by the judiciary.



Design Intervention For Community Outreach

The programme focuses on providing training in various design-oriented skills to women of the neighboring villages. To empowering them by opening avenues of income generation and helping them to become professionals. This program is conducted since 2016 onwards till date every year. This is Skill Training Program conducted by the Amity School of Fashion and Design Technology (ASFDT) at Amity University Maharashtra. The Param Foundation (Navi Mumbai) has donated 30 sewing machines to School of Fashion Design & Technology, Mumbai, and the sewing machines are utilized during the Design Intervention program for the women.
