	(1) Under the Min. of Education, Govt. of India, funding support on Institution Innovation Council Mentorship program, Amity has been identified as a Mentor Institution. Five HEIs of repute, each from the State of Chhattisgarh, MP, Gujrat, Maharashtra and Tamil Nadu, have been assigned as Mentee Institutions. It was also informed to the Members that this activity will be financially supported by the Min. of Education.
