

Memorandum of Understanding

This Memorandum of Understanding (MOU) is made on this ____ day of _____, 2021 between **Amity University Chhattisgarh (Raipur) AUC** **Amity University Chhattisgarh (Raipur) AUC (hereinafter referred to as AUC)** having office at MANTH (KHARORA), State Highway 9, Raipur Baloda-Bazar, Chhattisgarh - 493225 (Raipur). which expression shall include its successor and assigns, represented through its Vice Chancellor, on the one part

And

PMA (Project Management Associates) India, a not-for-profit Registered Professional body of projects and business managers established in 1993 actively promoting Competence based Project Management, having it's office at 3rd Floor, Periyar Centre, Plot No. 1 & 2, Institutional Area, Jasola, New Delhi - 110025, hereinafter referred to as 'PMA' which expression shall include its successor and assigns, represented through its President, on other part.

Both the institutions **Amity University Chhattisgarh (Raipur) AUC** and **PMA (Project Management Associates) India**, herein after collectively shall be referred as "the Two Parties".

Amity University Chhattisgarh (Raipur) AUC is a part of 20-year old, leading education group of India, set up with a vision to contribute to nation-building through education, where currently 1,50,000+ students are pursuing 250 programmes across campuses in India and abroad.

Amity University Chhattisgarh (Raipur) is yet another landmark project by Amity to revolutionize the Indian higher education sector by providing globally benchmarked, research and employment-oriented education. Whereas PMA (Project Management Associates) India, actively promoting Competence based Project Management, based on adoption of the globally recognized modern 4 Level Certification (4LC) system in Project Management from International Project Management Association (IPMA) – a global federation of over 73 nations and a leading authority on Competent Project, Program and Portfolio Management, more than 100 industries in India have certified over 7500 professionals by implementing IPMA 4LC. Various Corporate, Defense, PSUs, and reputed educational institutions like IITs & IIMs have already adopted the IPMA 4LC system in a big way for PM Competence development and assessment of their Project Professionals.

1. Scope:

PMA will be partnering with **Amity University Chhattisgarh (AUC)** for offering Project Management Training & Certification **IPMA Level-D** for the **MBA** students from this academic session with a weightage of **3** credits and an option for students to obtain the Certification from IPMA.

2. Role & Responsibility of PMA

- Provide faculty Training/Certification for min 2 faculty Members, who will deliver the Course to the Students after IPMA Level D Certification.
- Some guest lectures to be organized by PMA for the students.
- Certification exam to be conducted by PMA.
- Certificate to be issued by International Project Management Association (IPMA) after successful completion.

3. Role & Responsibility of Amity University Chhattisgarh (AUC)

- Proposed Course to be included & embedded in the MBA Course Curriculum conducted at University with a weightage of 03 credits from this academic year.
- To give students an option to obtain the IPMA Certification.
- To promote and Propagate the Course so that maximum students opt for Certification.
- Course to be conducted by AUC Faculty after Certification by IPMA.

4. Program Details

- IPMA Level D certification program is the foundation Level Certification and highly recommended for a wide audience of Project Professionals. The IPMA Level D Program is of about 40 Hrs duration.

5. Financial Terms & Conditions

i). Fee structure for PMA:-

- a. Special Pricing by IPMA Level D global Certification is going to be Rs. 10,000/- plus 18% GST per Student against regular fee of Rs 29,000/- + GST
- b. Special Pricing by IPMA Level D global Certification is going to be Rs. 10,000/- plus 18% GST per faculty member against regular fee of Rs 29,000/- + GST but both the parties will ensure that majority of the students opt for IPMA Level D Certification
- c. The students who opt for the certification will directly pay the fee to IPMA . Amity University Chhattisgarh shall have no financial involvement

6. General Terms & Conditions:

- a) This MoU shall be effective from the date of affixture of signatures of the parties and with remain in force for a period of five years.
- b) This MoU will be reviewed by the partnership committee members, if need be, from time to time and may be amended with the consent of both the parties and thereafter confirmed in writing.
- c) The parties agree and acknowledge that no other rights are granted except as explicitly stated herein.
- d) Neither party shall transfer or assign its interests, obligations or rights in this agreement without the written consent of the parties, provided that such.

- e) Neither party shall be liable by reason of failure or delay in the performance of its obligation under this MoU, if such failure or delay is caused by the acts of God, Strikes, Lockouts or any other causes beyond its control and without its fault or negligence or mutual agreement.
- f) Any other arrangement to the MoU or activities or commitments shall be made on mutually agreed terms from time to time.
- g) No amendments to the MoU shall be valid unless executed in writing and signed by both the parties.
- h) Payment needs to be facilitated /done by **Amity University Chhattisgarh (AUC)** maximum within 15 days after raising the invoice by PMA.

7. Tenure and Termination:

This MoU shall commence on the _____ and shall continue to be in force for a period of five (5) years or until terminated by either party. Either party may terminate this MoU upon prior written notice of 60 days to the other party, which will however be subject to compliance and completion of all commitments made. Notwithstanding any such termination, both parties shall ensure that all activities in progress are completed successfully.

8. Relationship between the parties:

It is expressly agreed that First Party and Second Party are acting under this MOU as independent entities, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

- 9. Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right or obligation to provide or receive the above-mentioned services only from each other on account of this MoU.
